Transaction Summary

The transaction closed on Mar 31 2017 and matures in Mar 2027. The pool's current aggregate principal balance is \$544.4 million compared to \$558.4 million at close.

The largest loan of the pool (12.9%) is secured by Charlotte Plaza located in metropolitan area. Occupancy at the subject was 70%. The major tenants included Lowe's Home Improvement (31.75%) and PIPER SANDLER & CO. (4.14%). The second largest loan of the pool (11.0%) is secured by Hotel Gansevoort located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 90%. The third largest loan of the pool (9.4%) is secured by Greenwich Financial Center located in metropolitan area. Occupancy at the subject was 98%. The major tenants included Morgan Stanley (30.97%) and Balyasny Asset Management LP (24.63%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.70% and 66 months as of 04/10/2022, respectively. There are a total of 20 loans and 23 properties in the portfolio. The appraisal LTV was approximately 61.9% compared to the Original loan to value (LTV), which was approximately 62.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.39x. As of 04/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.





Occupancy Distribution (%)




Local Distribution





There were 1 assets (8% of total balance) with NOI debt yield between -4% and -2%, 6 assets (36% of total balance) with NOI debt yield between 6% and 8%, 6 assets (27% of total balance) with NOI debt yield between 8% and 10%, 4 assets (20% of total balance) with NOI debt yield between 10% and 12%, 1 assets (1% of total balance) with NOI debt yield between 12% and 14%, 1 assets (2% of total balance) with NOI debt yield between 16% and 18%, 1 assets (6% of total balance) with NOI debt yield between 22% and 24%





DSCRs ranged from -0.5x to 3.0x.There are 1 assets (7.9% of total balance) with DSCR between -0.5x and 0.0x, 9 assets (50.6% of total balance) with DSCR between 1.0x and 1.5x, 5 assets (14.0% of total balance) with DSCR between 1.5x and 2.0x, 4 assets (22.0% of total balance) with DSCR between 2.0x and 2.5x and 1 assets (5.5% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 1.5x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
