## **Transaction Summary**

The transaction closed on Dec 18 2013 and matures in Dec 2028. The pool's current aggregate principal balance is \$811.4 million compared to \$880.6 million at close.

The largest loan of the pool (15.5%) is secured by Stonestown Galleria located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 98%. The major tenants included CITY SPORTS INC. (8.16%) and Target (5.44%). The second largest loan of the pool (14.8%) is secured by The Mall at Chestnut Hill located in Cambridge-Newton-Framingham, MA metropolitan area. Occupancy at the subject was 90%. The major tenants included Crate & Barrel (7.89%) and Uniqlo (5.45%). The third largest loan of the pool (5.0%) is secured by Residence Inn by Marriott Philadelphia located in Philadelphia, PA metropolitan area. Occupancy at the subject was 69%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.92% and 83 months as of 10/15/2020, respectively. There are a total of 54 loans and 62 properties in the portfolio. The appraisal LTV was approximately 58.9% compared to the Original loan to value (LTV), which was approximately 62.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.81x. As of 10/15/2020, 1.81% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.





## Occupancy Distribution (%)




#### Local Distribution









# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
