Transaction Summary

The transaction closed on Dec 18 2013 and matures in Dec 2028. The pool's current aggregate principal balance is \$790.5 million compared to \$880.6 million at close.

The largest loan of the pool (15.5%) is secured by Stonestown Galleria located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 65%. The major tenants included Target (14.91%) and CITY SPORTS INC. (8.16%). The second largest loan of the pool (15.2%) is secured by The Mall at Chestnut Hill located in Cambridge-Newton-Framingham, MA metropolitan area. Occupancy at the subject was 94%. The major tenants included Crate & Barrel (7.89%) and Uniqlo (5.45%). The third largest loan of the pool (4.9%) is secured by Residence Inn by Marriott Philadelphia located in Philadelphia, PA metropolitan area. Occupancy at the subject was 29%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.92% and 100 months as of 03/15/2022, respectively. There are a total of 54 loans and 62 properties in the portfolio. The appraisal LTV was approximately 57.3% compared to the Original loan to value (LTV), which was approximately 62.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.53x. As of 03/15/2022, 1.79% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 82%.





Occupancy Distribution (%)




Local Distribution









DSCRs ranged from 0.0x to 6.0x. There are 3 assets (7.0% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (2.7% of total balance) with DSCR between 0.5x and 1.0x, 9 assets (25.0% of total balance) with DSCR between 1.0x and 1.5x, 20 assets (42.8% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (14.4% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (3.4% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (0.8% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (2.1% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (1.1% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (0.7% of total balance) with DSCR between 5.5x and 6.0x. The most recent weighted average DSCR is 1.6x.

There are 1 assets (14.2% of total balance) that have maturity dates between 2018/7 and 2018/12, 51 assets (763.4% of total balance) that have maturity dates between 2023/7 and 2023/12 and 2 assets (12.9% of total balance) that have maturity dates between 2028/7 and 2028/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
