## Transaction Summary

The transaction closed on Feb 14 2014 and matures in Nov 2033. The pool's current aggregate principal balance is \$706.8 million compared to \$801.1 million at close.

The largest loan of the pool (16.0%) is secured by AmericasMart located in metropolitan area. Occupancy at the subject was 77%. The major tenants included exhibition space (23.14%) and APPELMAN/SCHAUBEN & CO. INC. (0.94%). The second largest loan of the pool (10.1%) is secured by JW Marriott and Fairfield Inn & Suites located in metropolitan area. Occupancy at the subject was 50%. The third largest loan of the pool (9.0%) is secured by Sun Communities Portfolio located in Warren-Troy-Farmington Hills, MI-24.90% Miami-Miami Beach-Kendall, FL-20.34% metropolitan area. Occupancy at the subject was 91%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.07% and 100 months as of 04/15/2022, respectively. There are a total of 39 loans and 49 properties in the portfolio. The appraisal LTV was approximately 55.4% compared to the Original loan to value (LTV), which was approximately 61.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.61x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 82%.

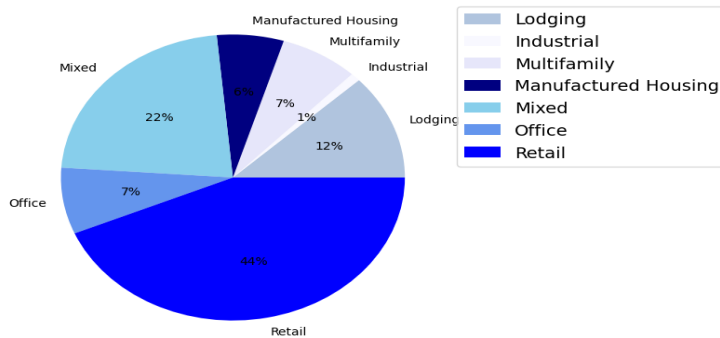

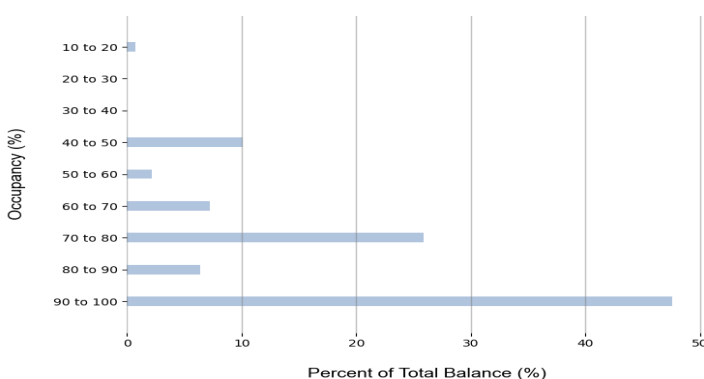

### Occupancy Distribution (%)



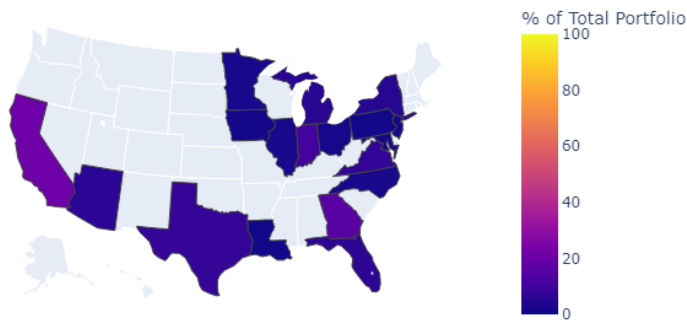

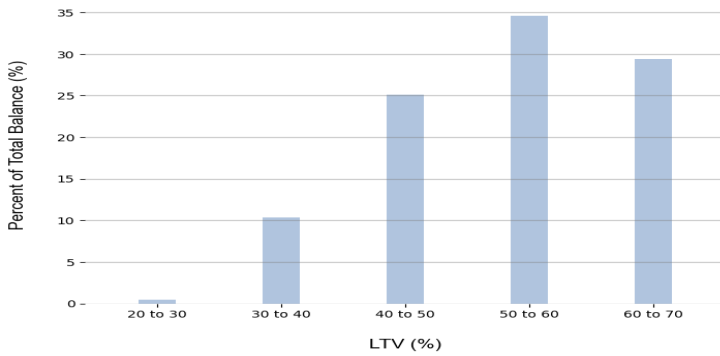
Local Distribution

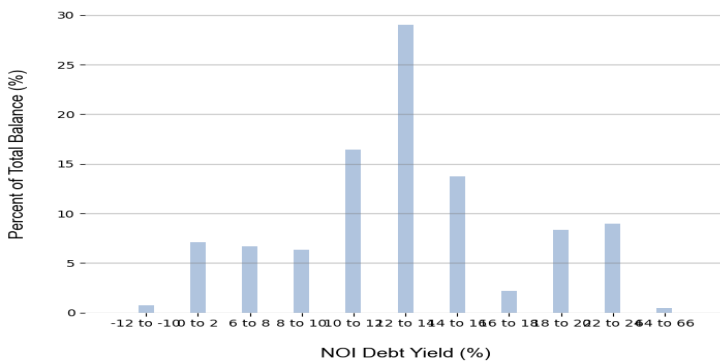

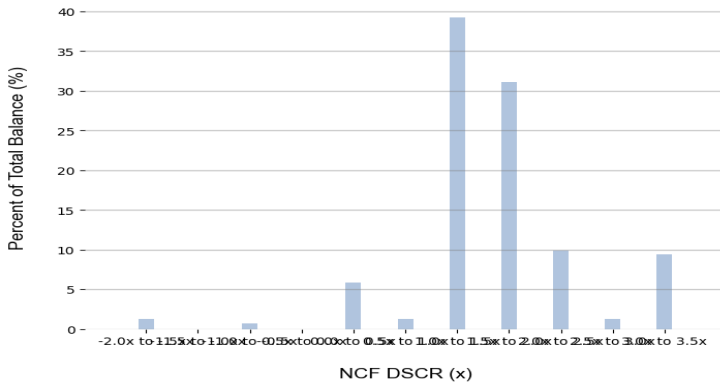
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from -12% to 65% with a weighted average NOI debt yield of 13.1%. NOI debt yield ranged from -12% to 65%. Net Cash Flow DSCR (x)

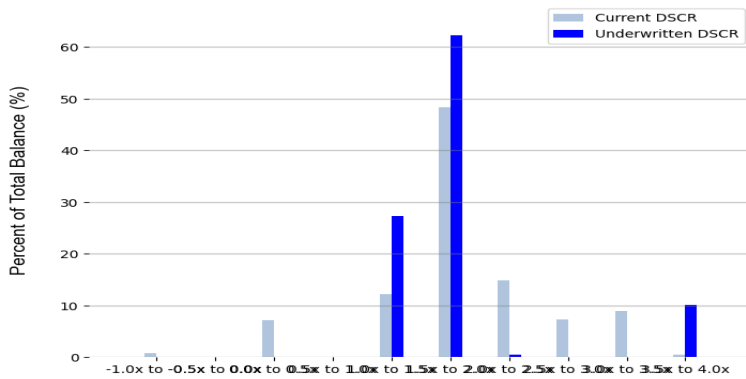

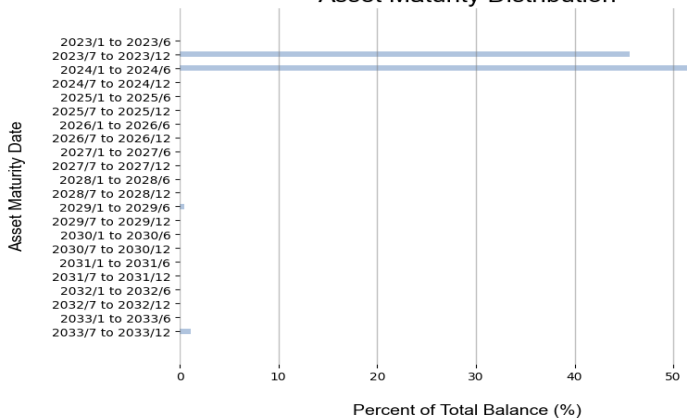
**DSCR Distribution (x)**

There are 1 assets (0.7% of total balance) with DSCR between -1.0x and -0.5x, 2 assets (7.1% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (12.3% of total balance) with DSCR between 1.0x and 1.5x, 21 assets (48.3% of total balance) with DSCR between 1.5x and 2.0x, 6 assets (14.9% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (7.3% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (9.0% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.5% of total balance) with DSCR between 3.5x and 4.0x. There are 14 assets (322.0% of total balance) that have maturity dates between 2023/7 and 2023/12, 23 assets (373.7% of total balance) that have maturity dates between 2024/1 and 2024/6, 1 assets (3.4% of total balance) that have maturity dates between 2029/1 and 2029/6 and 1 assets (7.8% of total balance) that have maturity dates between 2033/7 and 2033/12.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
