Transaction Summary

The transaction closed on Apr 15 2014 and matures in Apr 2024. The pool's current aggregate principal balance is \$853.3 million compared to \$925.3 million at close.

The largest loan of the pool (17.5%) is secured by Arundel Mills & Marketplace located in metropolitan area. Occupancy at the subject was 99%. The major tenants included Live Casino Hotel Maryl (16.78%) and Bass Pro Shops (8.21%). The second largest loan of the pool (13.9%) is secured by AmericasMart located in metropolitan area. Occupancy at the subject was 82%. The major tenants included Exhibition Space (23.14%) and LINK 2 SALES LLC (0.83%). The third largest loan of the pool (8.9%) is secured by La Concha Hotel & Tower located in metropolitan area. Occupancy at the subject was 84%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.93% and 82 months as of 12/15/2020, respectively. There are a total of 38 loans and 65 properties in the portfolio. The appraisal LTV was approximately 58.0% compared to the Original loan to value (LTV), which was approximately 62.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.38x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.






Local Distribution









DSCRs ranged from 1.0x to 5.0x. There are 11 assets (13.7% of total balance) with DSCR between 1.0x and 1.5x, 14 assets (25.2% of total balance) with DSCR between 1.5x and 2.0x, 3 assets (3.6% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (33.8% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (17.9% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.2% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (5.7% of total balance) with DSCR between 4.5x and 5.0x. The most recent weighted average DSCR is 2.6x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
