Transaction Summary

The transaction closed on Aug 14 2014 and matures in Jun 2039. The pool's current aggregate principal balance is \$695.3 million compared to \$766.4 million at close.

The largest loan of the pool (12.5%) is secured by Marriott Philadelphia Downtown located in Philadelphia, PA metropolitan area. Occupancy at the subject was 24%. The second largest loan of the pool (5.8%) is secured by San Isidro Plaza I & II located in metropolitan area. Occupancy at the subject was 86%. The major tenants included Lowe's Home Improvement (52.49%) and Regal Cinemas (17.33%). The third largest loan of the pool (5.3%) is secured by Courtyard King Kamehameha's Kona Beach Hotel Leased Fee located in metropolitan area. Occupancy at the subject was 100%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.75% and 93 months as of 03/15/2022, respectively. There are a total of 54 loans and 58 properties in the portfolio. The appraisal LTV was approximately 63.0% compared to the Original loan to value (LTV), which was approximately 67.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.07x. As of 03/15/2022, 5.80% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 75%.





Occupancy Distribution (%)






Local Distribution





Most recent net operating income debt yield ranged from -2% to 21% with a weighted average NOI debt yield of 7.5%. NOI debt yield ranged from -2% to 21%. 



EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
