Transaction Summary

The transaction closed on Jan 29 2015 and matures in Dec 2029. The pool's current aggregate principal balance is \$928.0 million compared to \$1022.7 million at close.

The largest loan of the pool (11.4%) is secured by Discovery Business Center located in Anaheim-Santa Ana-Irvine, CA metropolitan area. Occupancy at the subject was 86%. The major tenants included DaVita (5.09%) and Kofax Inc (4.94%). The second largest loan of the pool (7.4%) is secured by Orlando Maitland Office Portfolio located in metropolitan area. Occupancy at the subject was 100%. The major tenants included METAVANTE CORP (33.66%) and Charles Schwab (21.90%). The third largest loan of the pool (4.0%) is secured by Linc LIC (Pooled) located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 67%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.48% and 88 months as of 03/15/2022, respectively. There are a total of 77 loans and 88 properties in the portfolio. The appraisal LTV was approximately 61.0% compared to the Original loan to value (LTV), which was approximately 65.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.64x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 81%.





Occupancy Distribution (%)




Local Distribution









EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
