Transaction Summary

The transaction closed on Dec 21 2016 and matures in Jan 2027. The pool's current aggregate principal balance is \$879.1 million compared to \$907.3 million at close.

The largest loan of the pool (7.2%) is secured by Hilton Hawaiian Village - Trust located in metropolitan area. Occupancy at the subject was 93%. The second largest loan of the pool (6.3%) is secured by 191 Peachtree located in metropolitan area. Occupancy at the subject was 92%. The major tenants included Deloitte & Touche (21.27%) and Morgan and Morgan (6.26%). The third largest loan of the pool (5.8%) is secured by Wolfchase Galleria located in metropolitan area. Occupancy at the subject was 81%. The major tenants included Malco Theatres (7.92%) and H&M (5.65%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.31% and 49 months as of 12/15/2020, respectively. There are a total of 56 loans and 76 properties in the portfolio. The appraisal LTV was approximately 56.9% compared to the Original loan to value (LTV), which was approximately 58.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.38x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.

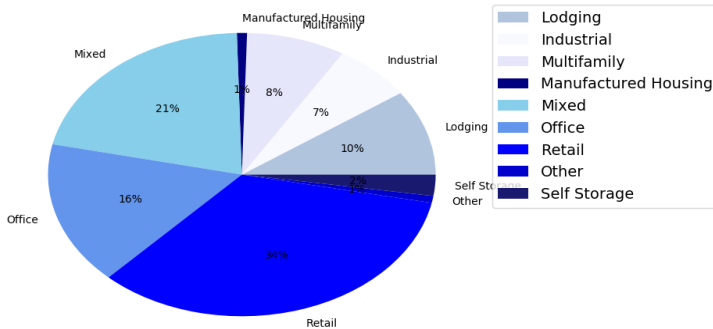

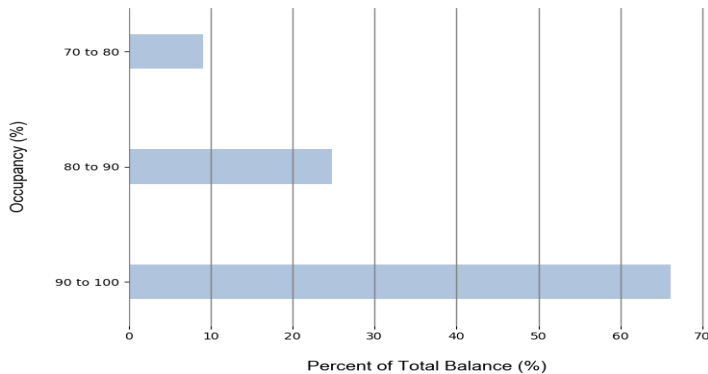

Occupancy Distribution (%)

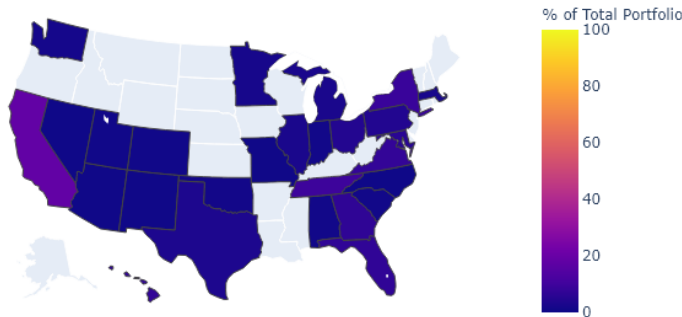

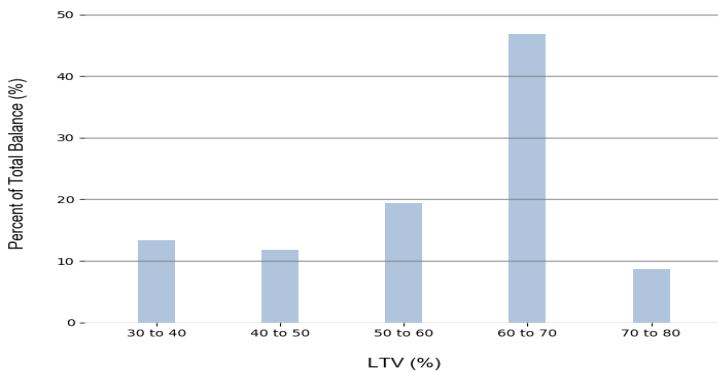
Local Distribution

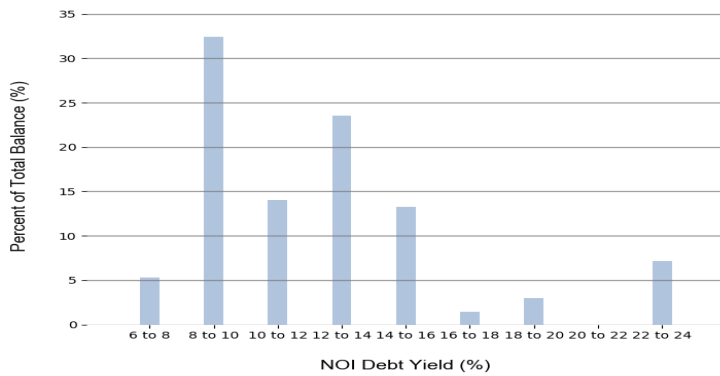

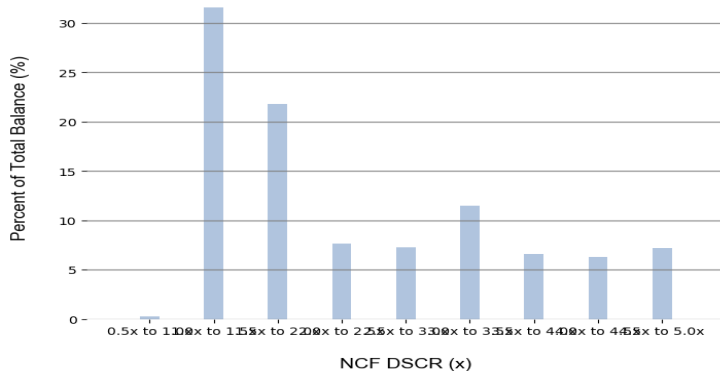
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

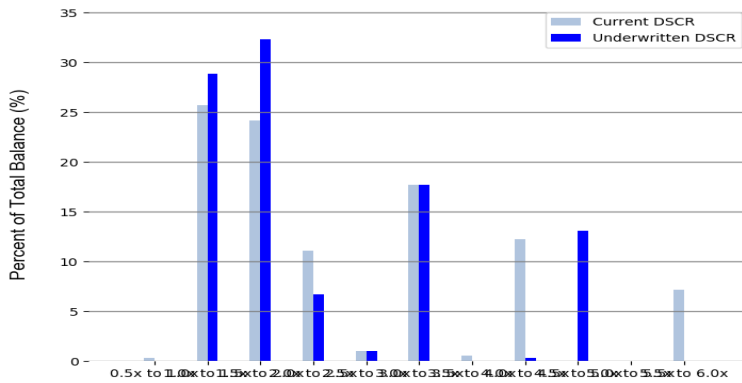

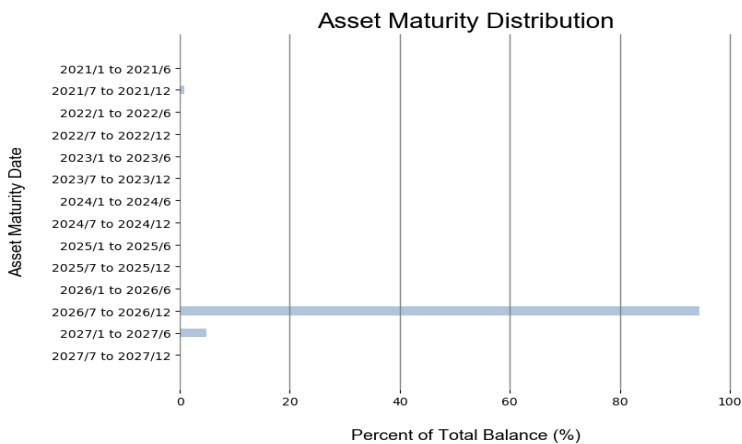

DSCRs ranged from 0.5x to 6.0x. There are 1 assets (0.3% of total balance) with DSCR between 0.5x and 1.0x, 14 assets (25.7% of total balance) with DSCR between 1.0x and 1.5x, 19 assets (24.2% of total balance) with DSCR between 1.5x and 2.0x, 9 assets (11.1% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (1.0% of total balance) with DSCR between 2.5x and 3.0x, 6 assets (17.7% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.6% of total balance) with DSCR between 3.5x and 4.0x, 3 assets (12.3% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (7.2% of total balance) with DSCR between 5.5x and 6.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
