Transaction Summary

The transaction closed on Nov 22 2016 and matures in Nov 2026. The pool's current aggregate principal balance is \$699.3 million compared to \$726.0 million at close.

The largest loan of the pool (10.4%) is secured by 101 Hudson Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 76%. The major tenants included Merrill Lynch (28.94%) and FIRST DATA CORPORATION (5.99%). The second largest loan of the pool (9.7%) is secured by Harlem USA located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 95%. The major tenants included AMC Cinema (27.69%) and Old Navy (14.15%). The third largest loan of the pool (6.6%) is secured by Cole Retail Portfolio located in metropolitan area. Occupancy at the subject was 92%. The major tenants included Academy Sports + Outdoors (11.42%) and Hobby Lobby (10.41%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.92% and 50 months as of 12/15/2020, respectively. There are a total of 40 loans and 43 properties in the portfolio. The appraisal LTV was approximately 59.5% compared to the Original loan to value (LTV), which was approximately 60.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.18x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.

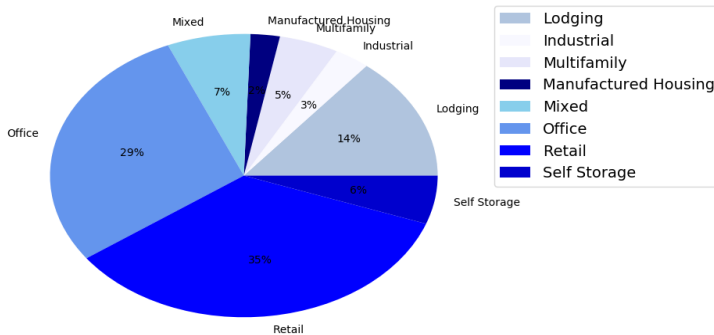

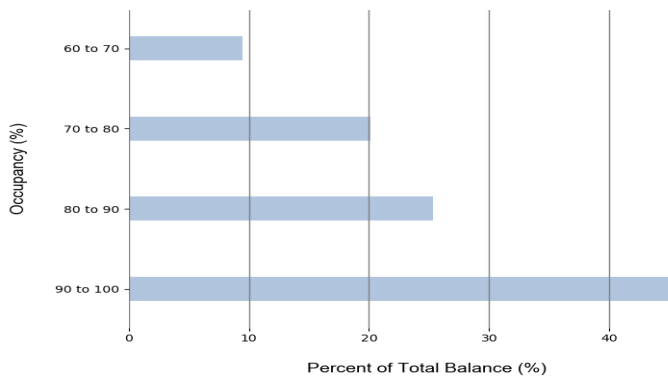

Occupancy Distribution (%)

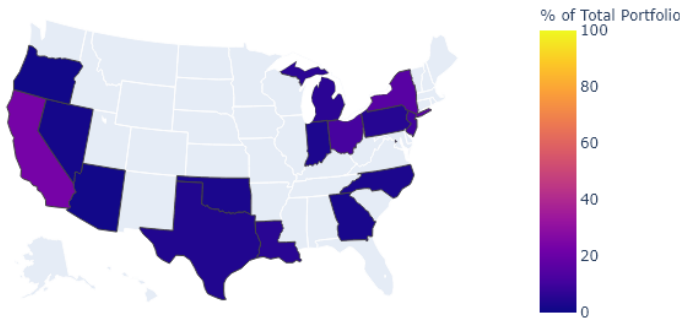

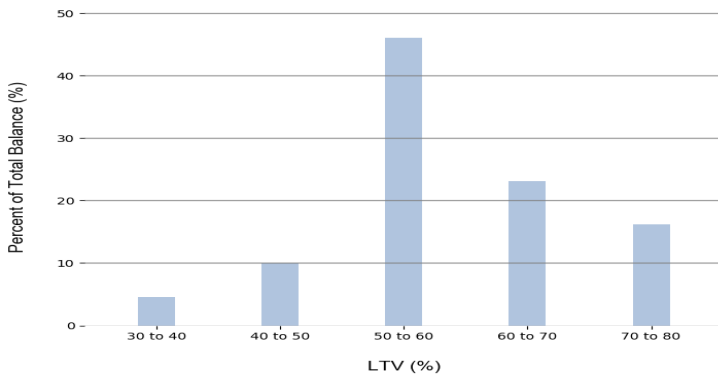
Local Distribution

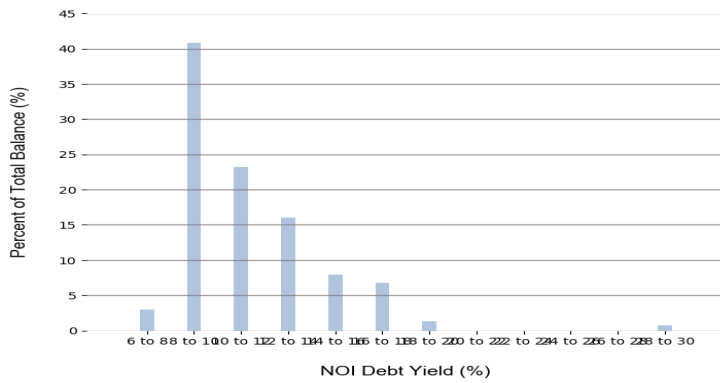

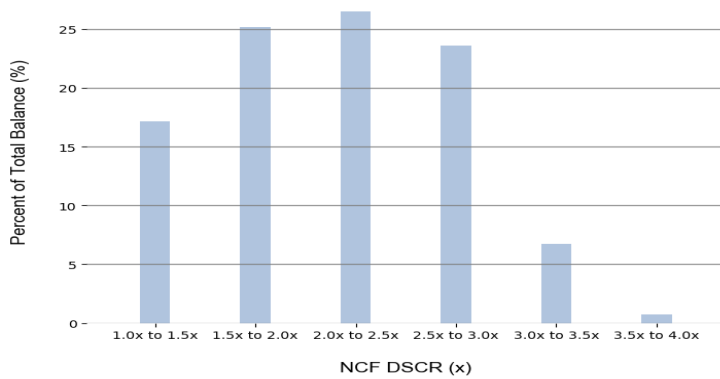
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 6% to 29% with a weighted average NOI debt yield of 11.3%. NOI debt yield ranged from 6% to 29%. There were 1 assets (3% of total balance) with NOI debt yield between 6% and 8%, 8 assets (41% of total balance) with NOI debt yield between 8% and 10%, 13 assets (23% of total balance) with NOI debt yield between 10% and 12%, 8 assets (16% of total balance) with NOI debt yield between 12% and 14%, 4 assets (8% of total balance) with NOI debt yield between 14% and 16%, 3 assets (7% of total balance) with NOI debt yield between 16% and 18%, 2 assets (1% of total balance) with NOI debt yield between 18% and 20%, 1 assets (1% of total balance) with NOI debt yield between 28% and 30%

Net Cash Flow DSCR (x)

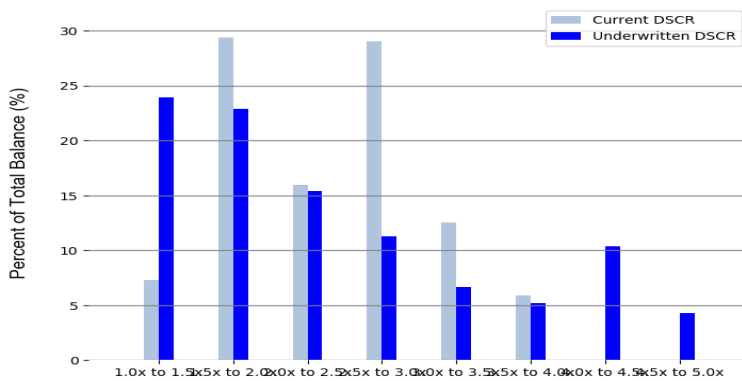


All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 4.0x. There were 7 assets (17.2% of total balance) with NCF DSCR between 1.0x and 1.5x, 10 assets (25.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 12 assets (26.5% of total balance) with NCF DSCR between 2.0x and 2.5x, 7 assets (23.6% of total balance) with NCF DSCR between 2.5x and 3.0x, 3 assets (6.8% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (0.7% of total balance) with NCF DSCR between 3.5x and 4.0x. The most recent weighted average NCF DSCR was 2.2x.

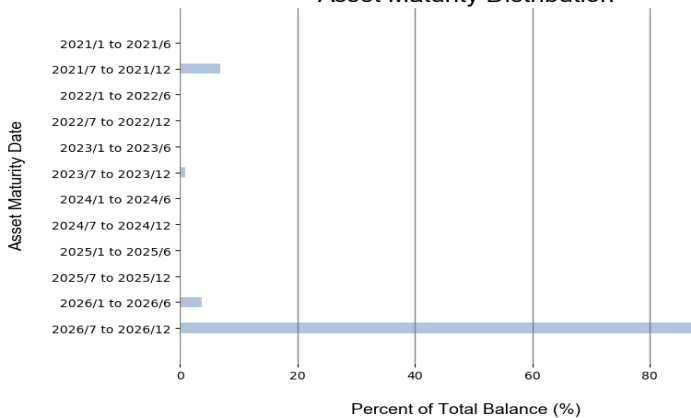
DSCR Distribution (x)



DSCRs ranged from 1.0x to 4.0x. There are 2 assets (7.3% of total balance) with DSCR between 1.0x and 1.5x, 14 assets (29.3% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (16.0% of total balance) with DSCR between 2.0x and 2.5x, 8 assets (29.0% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (12.5% of total balance) with DSCR between 3.0x and 3.5x and 3 assets (5.9% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 2.4x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
