Transaction Summary

The transaction closed on Jun 08 2017 and matures in May 2032. The pool's current aggregate principal balance is \$1068.7 million compared to \$1090.8 million at close.

The largest loan of the pool (6.1%) is secured by Market Street - The Woodlands located in metropolitan area. Occupancy at the subject was 96%. The major tenants included H-E-B Woodlands Market (16.79%) and Merrill Lynch (4.81%). The second largest loan of the pool (5.6%) is secured by Yeshiva University Portfolio located in New York-Jersey City-White Plains, NY-NJ-100.00% metropolitan area. Occupancy at the subject was 100%. The largest tenant was Yeshiva University (100.00%). The third largest loan of the pool (5.1%) is secured by iStar Leased Fee Portfolio located in Seattle-Bellevue-Everett, WA-17.62% Detroit-Dearborn-Livonia, MI-14.08% Dallas-Plano-Irving, TX-3.47% Washington-Arlington-Alexandria, DC-VA-MD-WV-2.29% metropolitan area. Occupancy at the subject was 83%. The major tenants included 500 Webward LLC (75.15%) and Trax International (9.42%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.76% and 42 months as of 10/15/2020, respectively. There are a total of 58 loans and 89 properties in the portfolio. The appraisal LTV was approximately 60.8% compared to the Original loan to value (LTV), which was approximately 60.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.81x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.

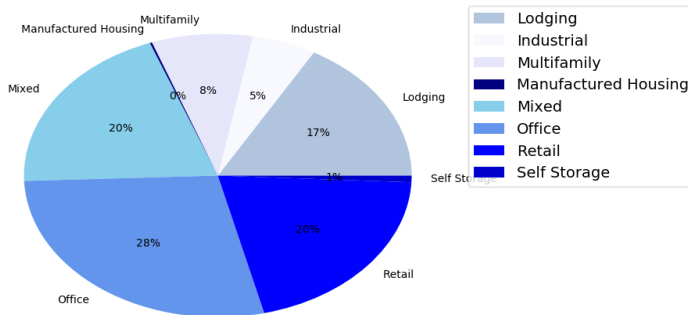

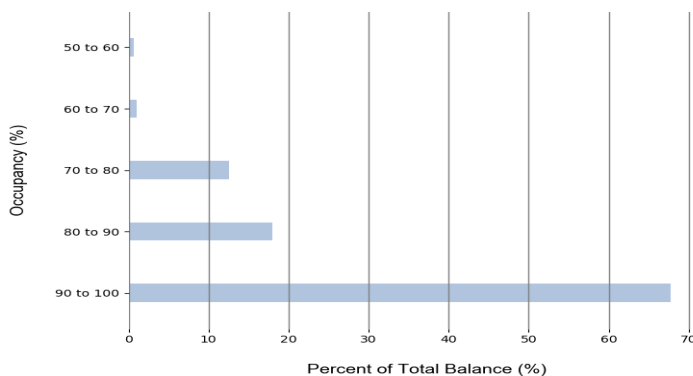

Occupancy Distribution (%)

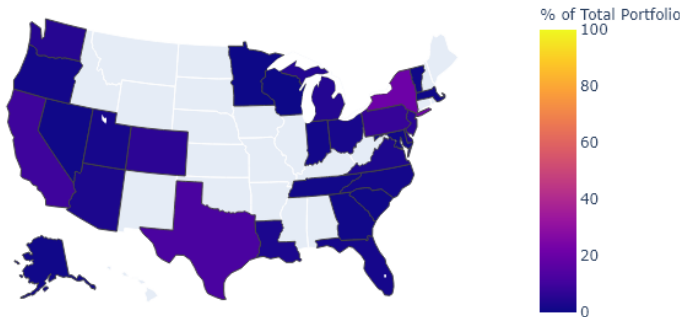

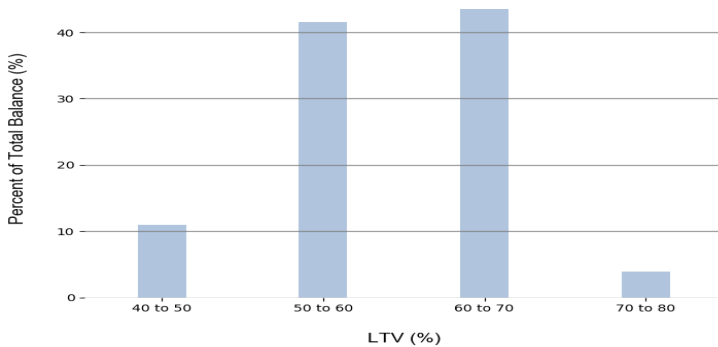
Local Distribution

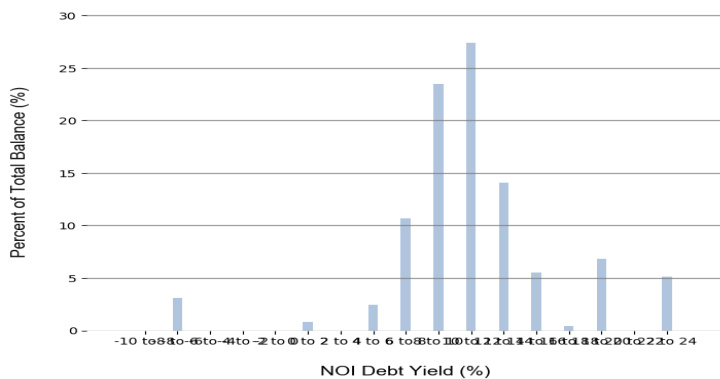

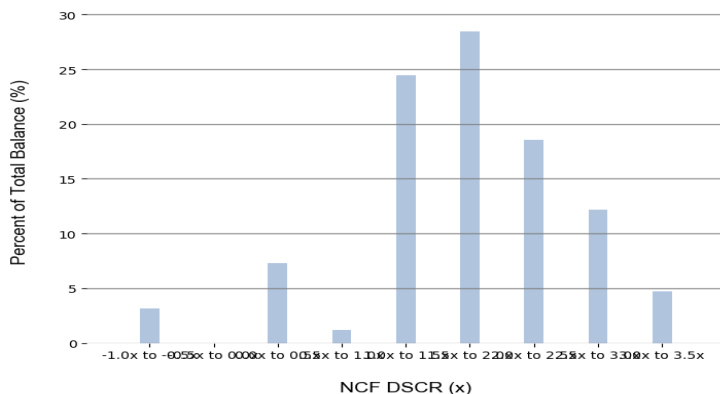
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

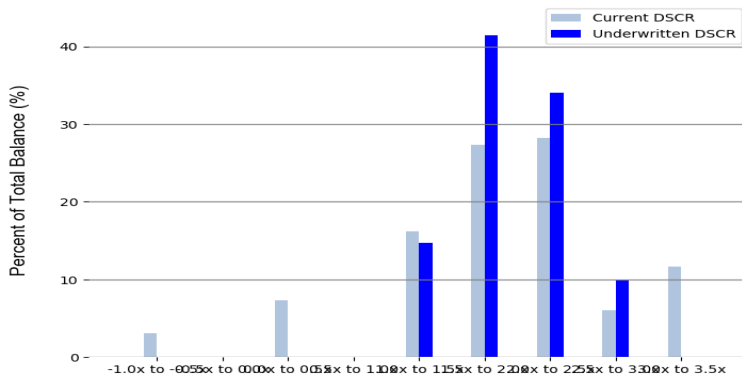

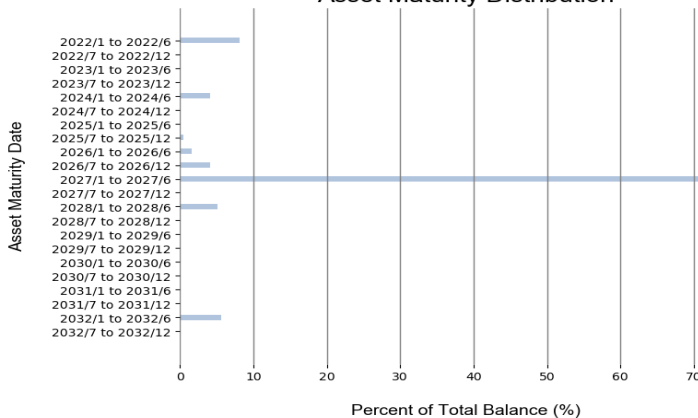
DSCR Distribution (x)

There are 1 assets (3.1% of total balance) with DSCR between -1.0x and -0.5x, 4 assets (7.3% of total balance) with DSCR between 0.0x and 0.5x, 12 assets (16.2% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (27.4% of total balance) with DSCR between 1.5x and 2.0x, 17 assets (28.3% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (6.0% of total balance) with DSCR between 2.5x and 3.0x and 4 assets (11.6% of total balance) with DSCR between 3.0x and 3.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
