## Transaction Summary

The transaction closed on Jun 08 2017 and matures in May 2032. The pool's current aggregate principal balance is \$1067.3 million compared to \$1090.8 million at close.

The largest loan of the pool (6.1%) is secured by Market Street - The Woodlands located in metropolitan area. Occupancy at the subject was 96%. The major tenants included H-E-B Woodlands Market (16.79%) and Merrill Lynch (4.81%). The second largest loan of the pool (5.6%) is secured by Yeshiva University Portfolio located in New York-Jersey City-White Plains, NY-NJ-100.00% metropolitan area. Occupancy at the subject was 100%. The largest tenant was Yeshiva University (100.00%). The third largest loan of the pool (5.2%) is secured by iStar Leased Fee Portfolio located in Seattle-Bellevue-Everett, WA-17.62% Detroit-Dearborn-Livonia, MI-14.08% Dallas-Plano-Irving, TX-3.47% Washington-Arlington-Alexandria, DC-VA-MD-WV-2.29% metropolitan area. Occupancy at the subject was 83%. The major tenants included 500 Webward LLC (75.15%) and Trax International (9.42%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.76% and 44 months as of 12/15/2020, respectively. There are a total of 58 loans and 89 properties in the portfolio. The appraisal LTV was approximately 62.1% compared to the Original loan to value (LTV), which was approximately 60.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.81x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.

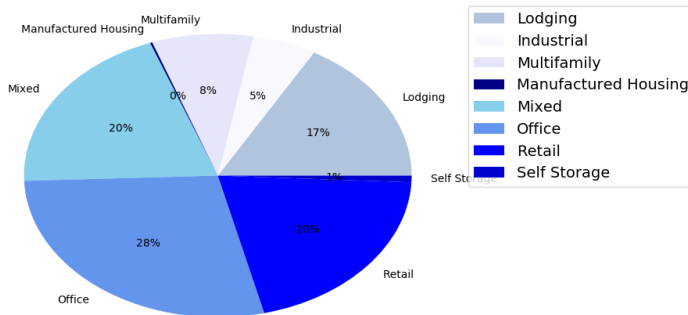

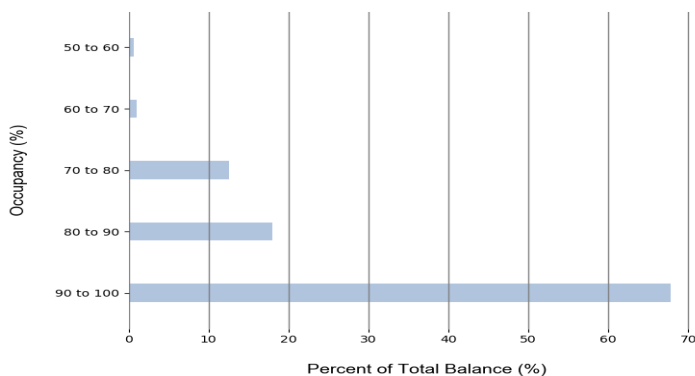

Occupancy Distribution (%)

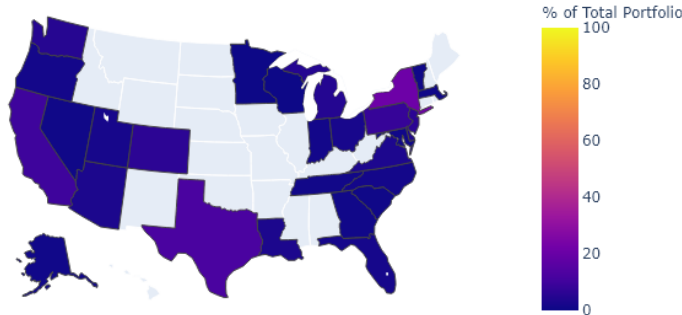

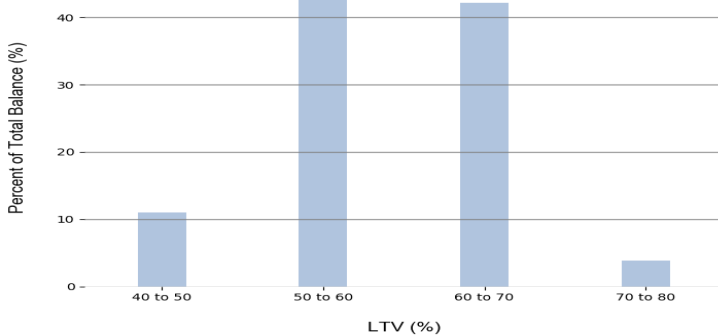
Local Distribution

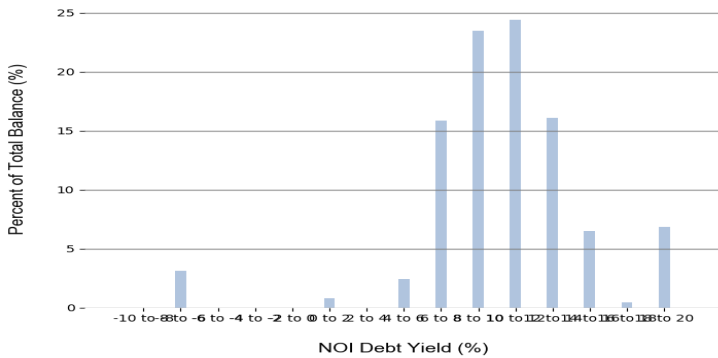

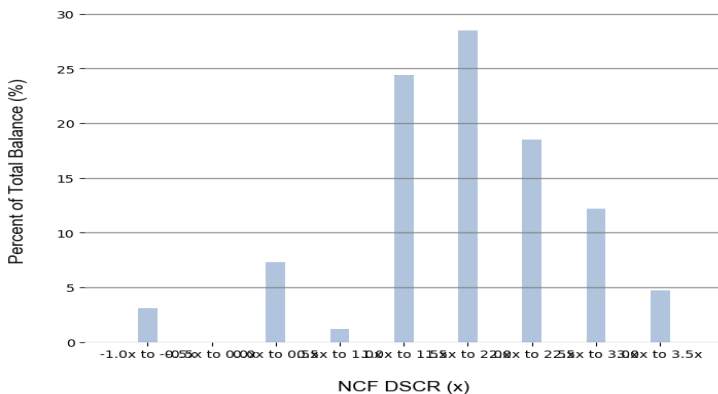
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

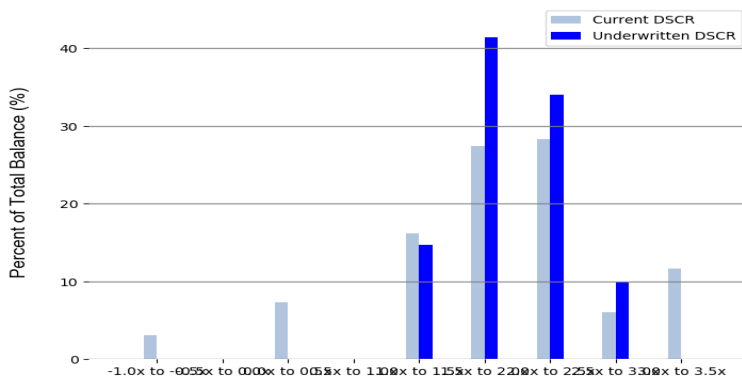


NCF DSCR ranged from -1.0x to 3.0x. 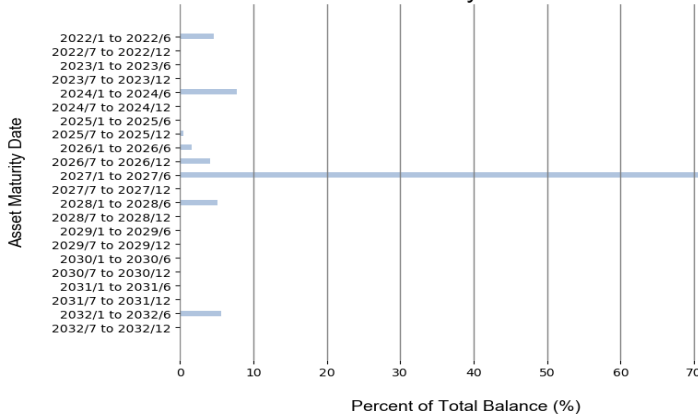
**DSCR Distribution (x)**

There are 1 assets (3.1% of total balance) with DSCR between -1.0x and -0.5x, 4 assets (7.3% of total balance) with DSCR between 0.0x and 0.5x, 12 assets (16.2% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (27.4% of total balance) with DSCR between 1.5x and 2.0x, 17 assets (28.3% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (6.1% of total balance) with DSCR between 2.5x and 3.0x and 4 assets (11.7% of total balance) with DSCR between 3.0x and 3.5x. There are 2 assets (4.6% of total balance) that have maturity dates between 2022/1 and 2022/6, 3 assets (7.7% of total balance) that have maturity dates between 2024/1 and 2024/6, 1 assets (0.4% of total balance) that have maturity dates between 2025/7 and 2025/12, 1 assets (1.7% of total balance) that have maturity dates between 2026/1 and 2026/6, 3 assets (4.1% of total balance) that have maturity dates between 2026/7 and 2026/12, 46 assets (70.7% of total balance) that have maturity dates between 2027/1 and 2027/6, 1 assets (5.2% of total balance) that have maturity dates between 2028/1 and 2028/6 and 1 assets (5.6% of total balance) that have maturity dates between 2032/1 and 2032/6.

## Sensitivity Analysis

EJR used the capitalization rates ("cap rates") listed below for the different types of the properties and then calculated the value of the properties in the portfolio by considering the most recent NCF and the various cap rates.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

There are three notches in each of EJR's rating categories (e.g., A-(sf), A(sf) and A+(sf) for category A(sf)) except for AAA(sf), CC(sf), C(sf) and D(sf).

### 2. The version of the procedure or methodology used to determine the credit rating as required by Paragraph (a)(1)(ii)(B) of Rule 17g-7:

We are using the Methodology for Rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) v1a and General Methodology for Rating Asset Backed and Structured Finance Obligations (Non-NRSRO) v1.

### 3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

### 4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:

- 1). Are not intended to address the value, price, price stability, liquidity, suitability, or merit of an investment.
