Transaction Summary

The transaction closed on Oct 23 2018 and matures in Oct 2028. The pool's current aggregate principal balance is \$895.5 million compared to \$900.7 million at close.

The largest loan of the pool (6.7%) is secured by Aventura Mall - Trust located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 100%. The major tenants included J. C. Penney Co. (15.90%) and AMC Theatres (6.50%). The second largest loan of the pool (6.7%) is secured by Griffin Portfolio II located in Elgin, IL-17.44% metropolitan area. Occupancy at the subject was 100%. The major tenants included 3M COMPANY (35.88%) and Amazon.com (31.41%). The third largest loan of the pool (6.2%) is secured by Millennium Partners Portfolio - Trust located in New York-Jersey City-White Plains, NY-NJ-44.82% Boston, MA-25.76% San Francisco-Redwood City-South San Francisco, CA-12.00% Washington-Arlington-Alexandria, DC-VA-MD-WV-9.17% Miami-Miami Beach-Kendall, FL-8.24% metropolitan area. Occupancy at the subject was 100%. The major tenants included Equinox (26.03%) and Loews Theater (14.30%).

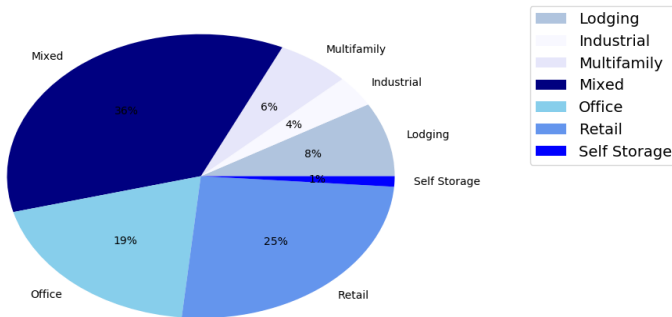
The weighted average coupon (WAC) and the weighted average age (WALA) were 4.82% and 26 months as of 10/15/2020, respectively. There are a total of 47 loans and 74 properties in the portfolio. The appraisal LTV was approximately 56.6% compared to the Original loan to value (LTV), which was approximately 56.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.88x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.

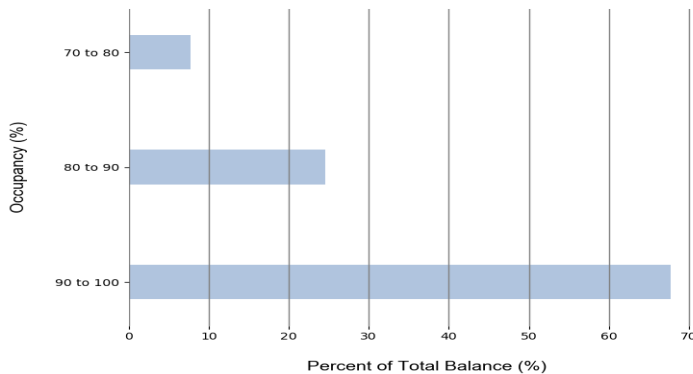

Occupancy Distribution (%)

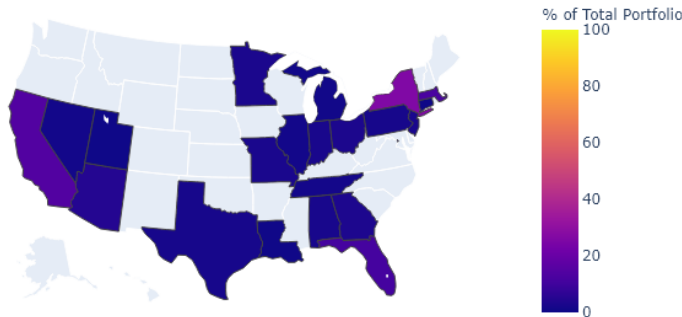

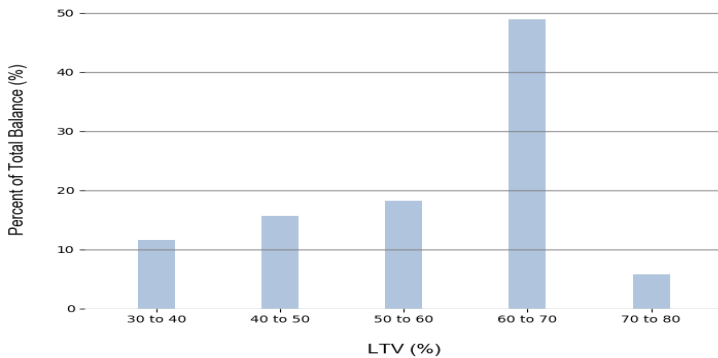
Local Distribution

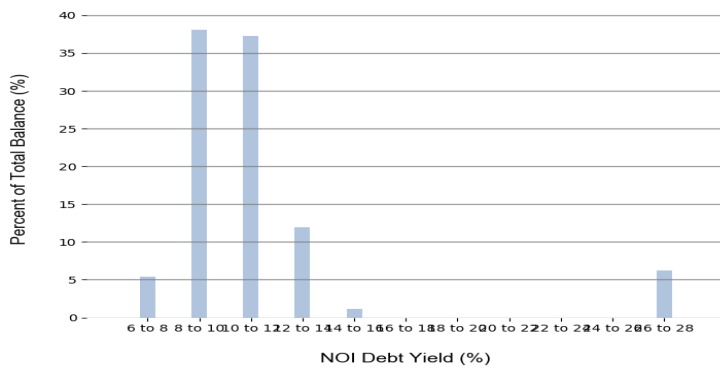

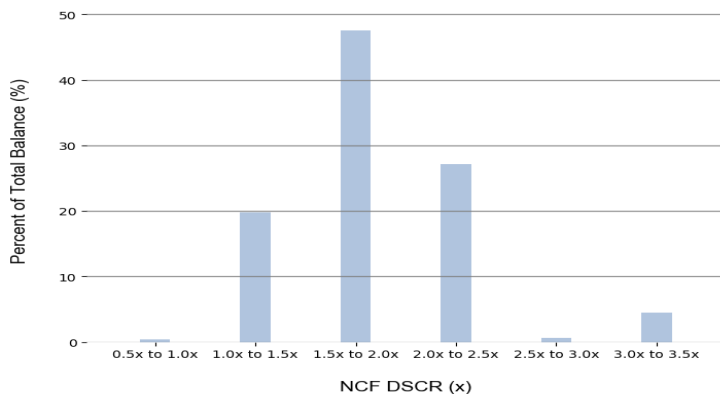
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 6% to 27% with a weighted average NOI debt yield of 11.3%. NOI debt yield ranged from 6% to 27%. There were 4 assets (5% of total balance) with NOI debt yield between 6% and 8%, 19 assets (38% of total balance) with NOI debt yield between 8% and 10%, 15 assets (37% of total balance) with NOI debt yield between 10% and 12%, 7 assets (12% of total balance) with NOI debt yield between 12% and 14%, 1 assets (1% of total balance) with NOI debt yield between 14% and 16%, 1 assets (6% of total balance) with NOI debt yield between 26% and 28%

Net Cash Flow DSCR (x)

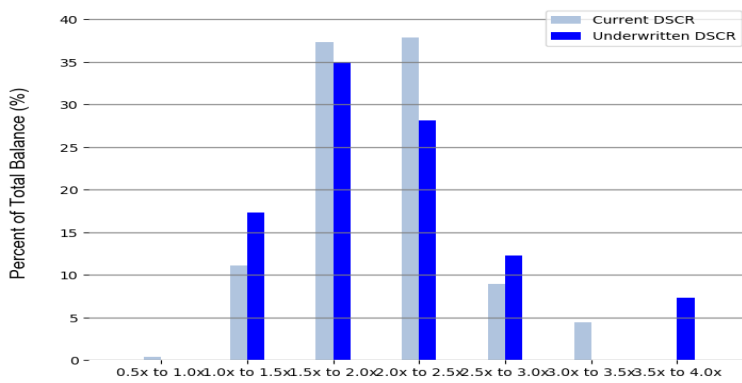

There were 1 assets (0.3% of total balance) with NCF DSCR between 0.5x and 1.0x, 13 assets (19.8% of total balance) with NCF DSCR between 1.0x and 1.5x, 21 assets (47.6% of total balance) with NCF DSCR between 1.5x and 2.0x, 10 assets (27.2% of total balance) with NCF DSCR between 2.0x and 2.5x, 1 assets (0.6% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (4.5% of total balance) with NCF DSCR between 3.0x and 3.5x. DSCRs ranged from 0.5x to 3.5x. There are 1 assets (0.3% of total balance) with DSCR between 0.5x and 1.0x, 7 assets (11.1% of total balance) with DSCR between 1.0x and 1.5x, 21 assets (37.3% of total balance) with DSCR between 1.5x and 2.0x, 13 assets (37.8% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (8.9% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (4.5% of total balance) with DSCR between 3.0x and 3.5x. The most recent weighted average DSCR is 2.0x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
