Transaction Summary

The transaction closed on Jul 19 2016 and matures in Oct 2045. The pool's current aggregate principal balance is \$668.5 million compared to \$709.1 million at close.

The largest loan of the pool (6.0%) is secured by The Mall at Rockingham Park - Pooled located in Rockingham County-Strafford County, NH metropolitan area. Occupancy at the subject was 90%. The major tenants included Lord & Taylor (29.32%) and Forever 21 (2.11%). The second largest loan of the pool (5.7%) is secured by 85 Bluxome located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 100%. The largest tenant was Collective Inc. (100.00%). The third largest loan of the pool (5.4%) is secured by 26 Astor Place located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 99%. The major tenants included JPMorgan Chase (46.29%) and The Alley (3.54%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.84% and 71 months as of 04/10/2022, respectively. There are a total of 43 loans and 134 properties in the portfolio. The appraisal LTV was approximately 62.2% compared to the Original loan to value (LTV), which was approximately 61.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.01x. As of 04/10/2022, 11.02% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 85%.

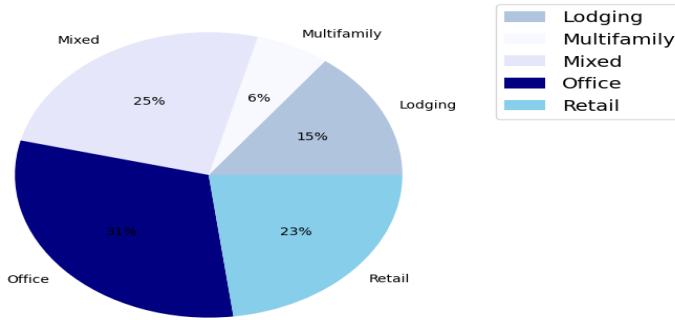

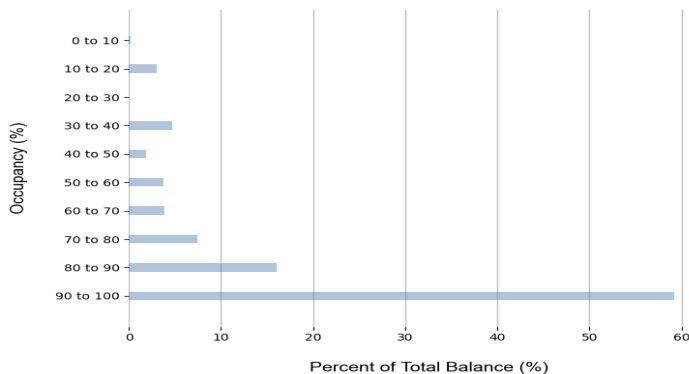

Occupancy Distribution (%)

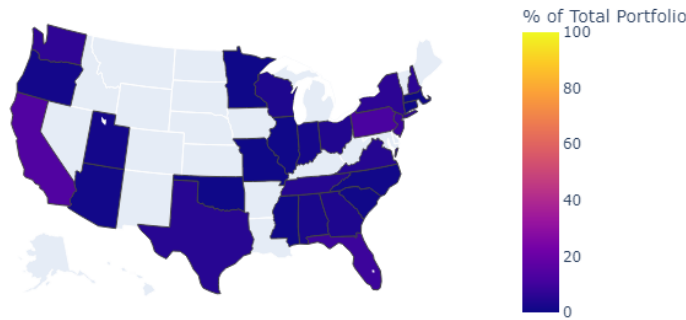

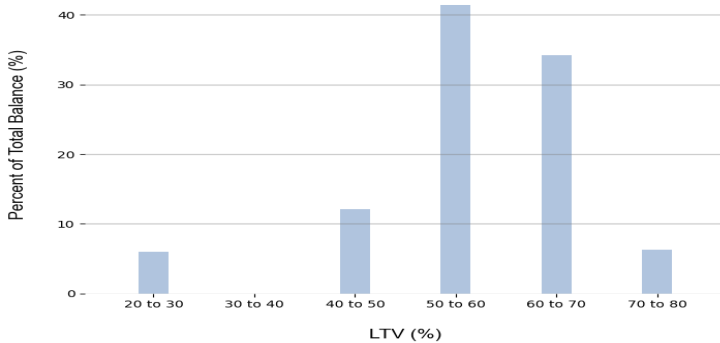
Local Distribution

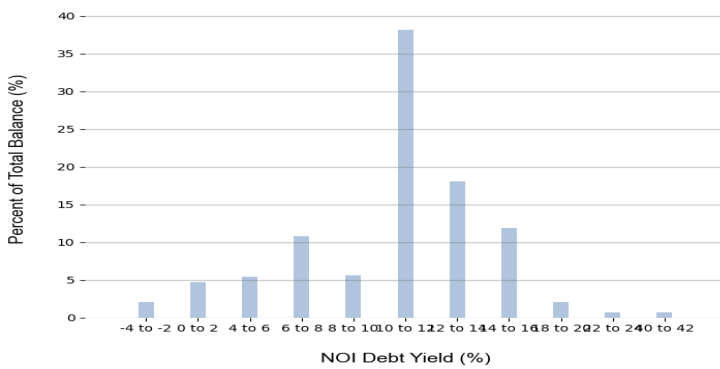

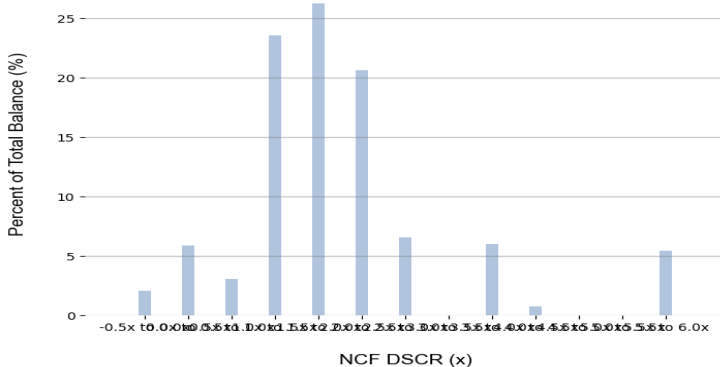
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

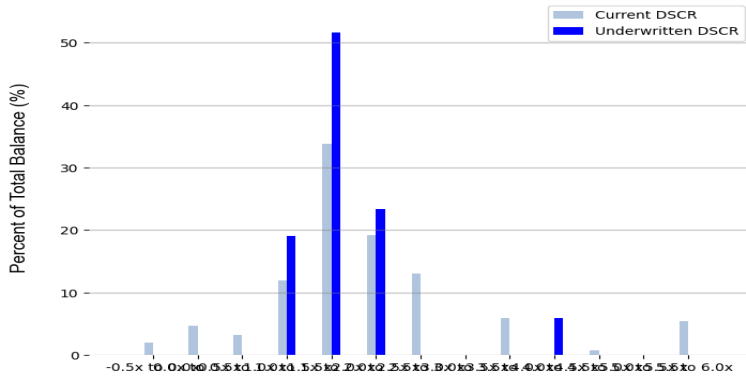

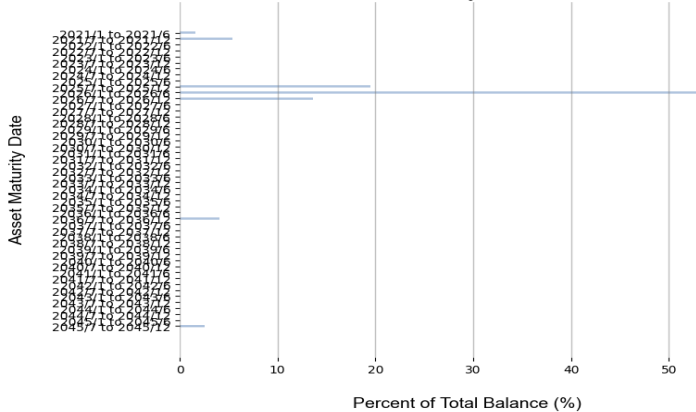
DSCR Distribution (x)



DSCRs ranged from -0.5x to 6.0x. There are 1 assets (2.0% of total balance) with DSCR between -0.5x and 0.0x, 1 assets (4.7% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (3.3% of total balance) with DSCR between 0.5x and 1.0x, 8 assets (12.0% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (33.8% of total balance) with DSCR between 1.5x and 2.0x, 5 assets (19.2% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (13.0% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (6.0% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (0.7% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (5.4% of total balance) with DSCR between 5.5x and 6.0x. There are 1 assets (10.8% of total balance) that have maturity dates between 2021/1 and 2021/6, 1 assets (36.0% of total balance) that have maturity dates between 2021/7 and 2021/12, 9 assets (130.2% of total balance) that have maturity dates between 2022/7 and 2022/12, 25 assets (356.7% of total balance) that have maturity dates between 2023/1 and 2023/6, 5 assets (91.0% of total balance) that have maturity dates between 2023/7 and 2023/12, 1 assets (26.8% of total balance) that have maturity dates between 2024/7 and 2024/12 and 1 assets (16.9% of total balance) that have maturity dates between 2045/7 and 2045/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
