Transaction Summary

The transaction closed on Aug 28 2018 and matures in Aug 2048. The pool's current aggregate principal balance is \$796.3 million compared to \$805.2 million at close.

The largest loan of the pool (6.3%) is secured by Wyvernwood Apartments located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 98%. The second largest loan of the pool (6.1%) is secured by Riverfront Plaza located in metropolitan area. Occupancy at the subject was 87%. The major tenants included Hunton Andrews Kurth (14.08%) and Hunton Andrews Kurth (10.38%). The third largest loan of the pool (5.7%) is secured by Riverwalk located in Cambridge-Newton-Framingham, MA metropolitan area. Occupancy at the subject was 87%. The major tenants included SOLECTRAI (18.60%) and PARTNERS COMMUNITY HEALTHCARE (12.36%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.98% and 27 months as of 10/15/2020, respectively. There are a total of 65 loans and 76 properties in the portfolio. The appraisal LTV was approximately 60.2% compared to the Original loan to value (LTV), which was approximately 59.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.92x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.

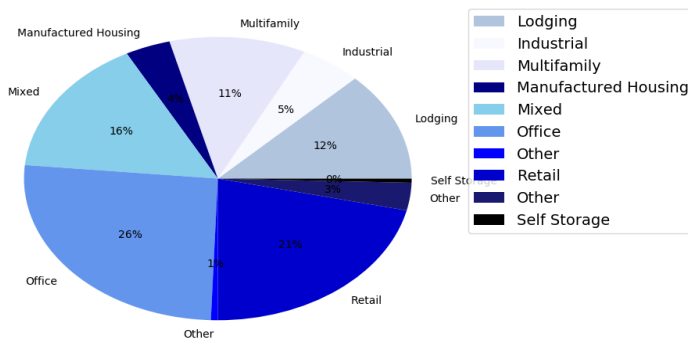

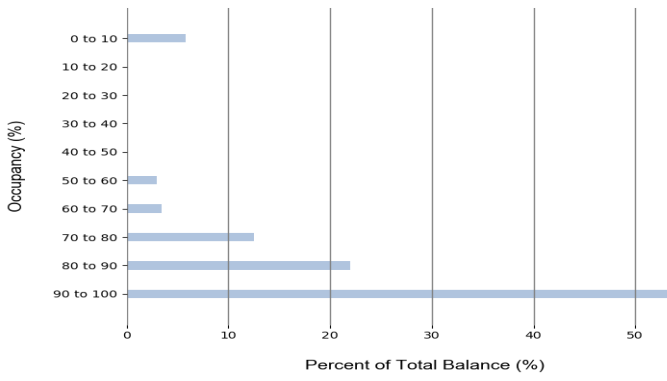

Occupancy Distribution (%)

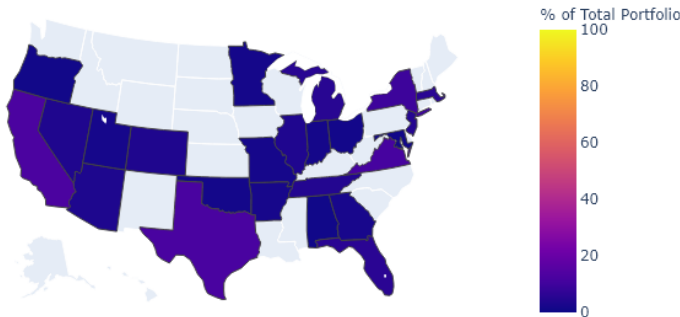

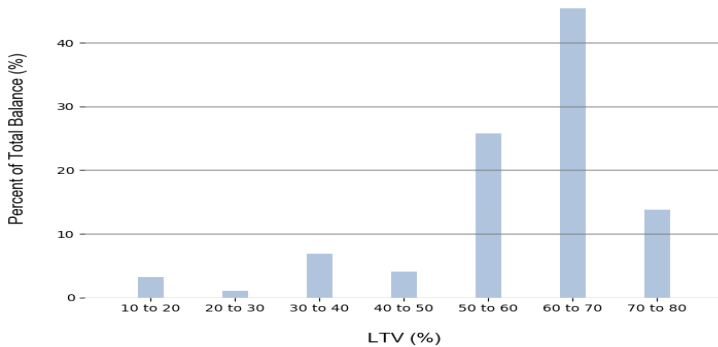
Local Distribution

LTV Distribution (%)



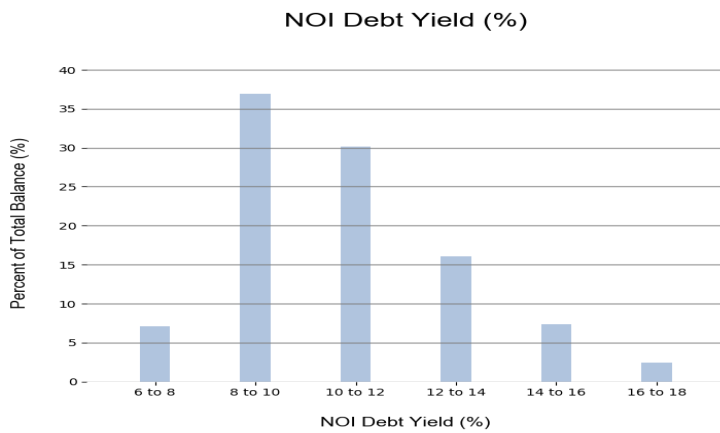

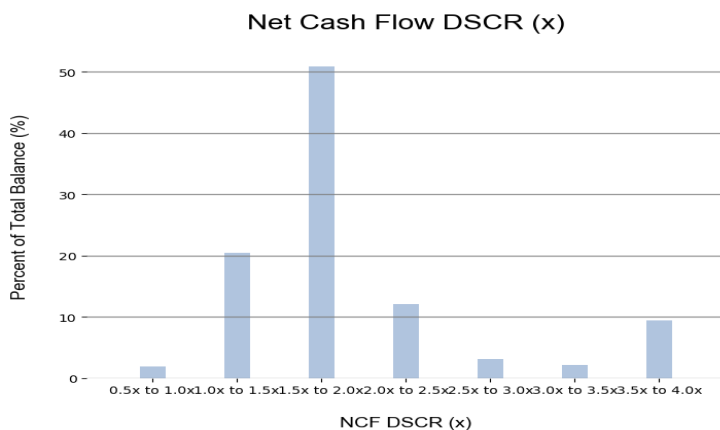

Most recent net operating income debt yield ranged from 6% to 17% with a weighted average NOI debt yield of 10.7%. NOI debt yield ranged from 6% to 17%. There were 3 assets (7% of total balance) with NOI debt yield between 6% and 8%, 26 assets (37% of total balance) with NOI debt yield between 8% and 10%, 18 assets (30% of total balance) with NOI debt yield between 10% and 12%, 9 assets (16% of total balance) with NOI debt yield between 12% and 14%, 7 assets (7% of total balance) with NOI debt yield between 14% and 16% and 2 assets (2% of total balance) with NOI debt yield between 16% and 18%.

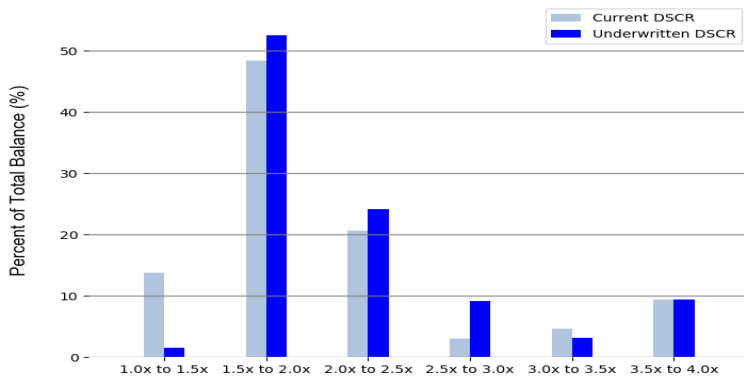


NCF DSCR ranged from 0.0x to 4.0x. There were 2 assets (1.9% of total balance) with NCF DSCR between 0.5x and 1.0x, 15 assets (20.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 33 assets (51.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (12.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (3.1% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (2.1% of total balance) with NCF DSCR between 3.0x and 3.5x and 2 assets (9.4% of total balance) with NCF DSCR between 3.5x and 4.0x. 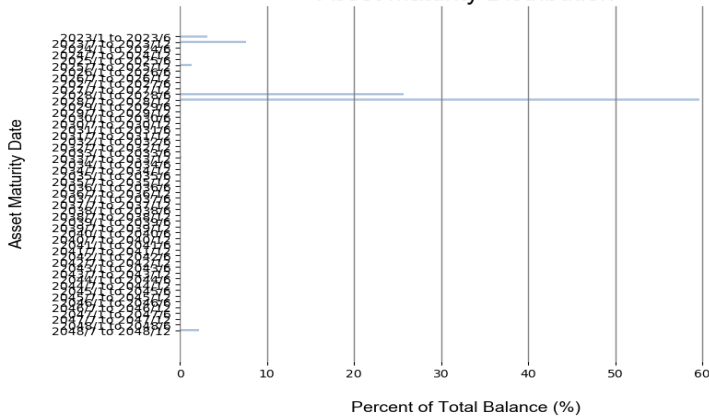
DSCR Distribution (x)



DSCRs ranged from 1.0x to 4.0x. There are 12 assets (13.8% of total balance) with DSCR between 1.0x and 1.5x, 29 assets (48.4% of total balance) with DSCR between 1.5x and 2.0x, 16 assets (20.6% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (3.1% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (4.6% of total balance) with DSCR between 3.0x and 3.5x and 2 assets (9.4% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 2.0x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
