## Transaction Summary

The transaction closed on Dec 28 2018 and matures in Oct 2033. The pool's current aggregate principal balance is \$639.4 million compared to \$646.6 million at close.

The largest loan of the pool (8.6%) is secured by Great Value Storage Portfolio located in Dallas-Plano-Irving, TX-6.36% Fort Worth-Arlington, TX-2.05% metropolitan area. Occupancy at the subject was 83%. The second largest loan of the pool (8.4%) is secured by Heartland Dental Medical Office Portfolio located in Dallas-Plano-Irving, TX-2.04% Washington-Arlington-Alexandria, DC-VA-MD-WV-1.64% Elgin, IL-1.28% Fort Worth-Arlington, TX-0.95% Warren-Troy-Farmington Hills, MI-0.90% Lake County-Kenosha County, IL-WI-0.60% Gary, IN-0.44% Rockingham County-Strafford County, NH-0.19% metropolitan area. Occupancy at the subject was 97%. The major tenants included HD home office (8.75%) and HD PSR Center (4.46%). The third largest loan of the pool (7.0%) is secured by Saint Louis Galleria located in metropolitan area. Occupancy at the subject was 99%. The major tenants included Dillard's (26.59%) and Macy's (22.21%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.13% and 25 months as of 12/15/2020, respectively. There are a total of 41 loans and 317 properties in the portfolio. The appraisal LTV was approximately 58.0% compared to the Original loan to value (LTV), which was approximately 57.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.09x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.

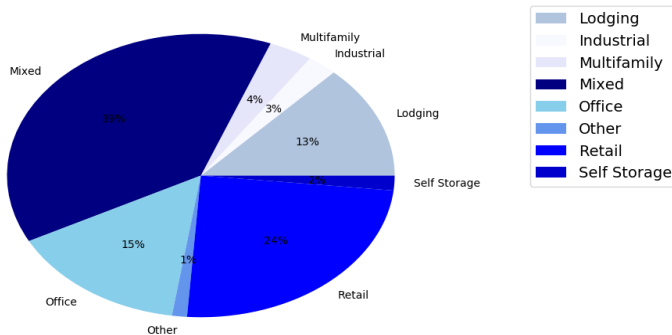

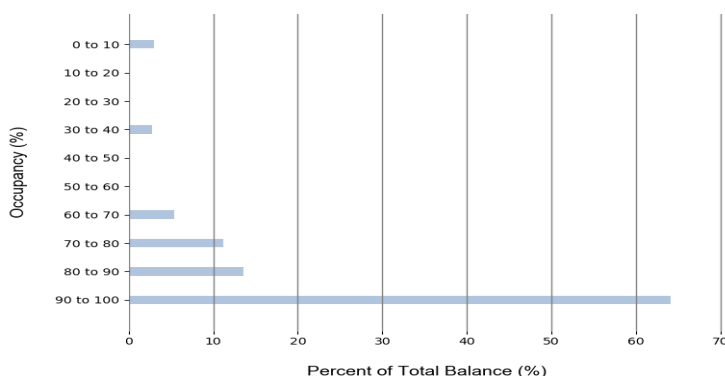

Occupancy Distribution (%)



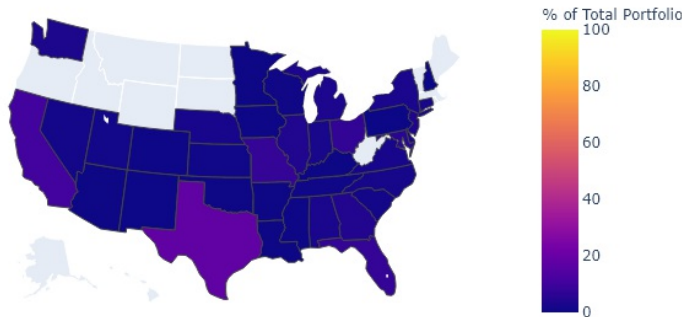

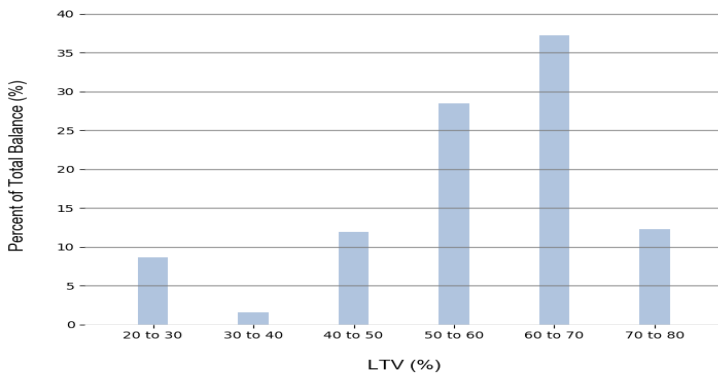
Local Distribution



Among assets in the portfolio, there are 55 properties (18% of total balance) located in Texas, 4 properties (11% of total balance) in California, 10 properties (8% of total balance) in Missouri, 45 properties (8% of total balance) in Florida, 25 properties (7% of total balance) in Ohio, 5 properties (6% of total balance) in Maryland, 18 properties (4% of total balance) in Georgia and 31 properties (4% of total balance) in Illinois. 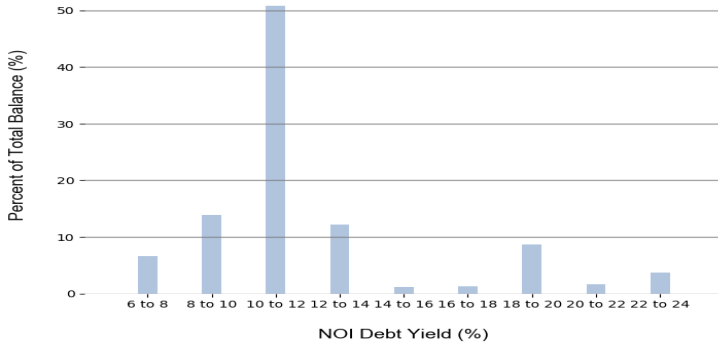

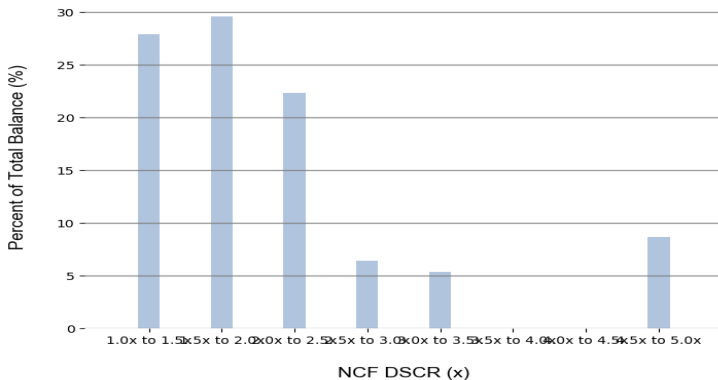
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 6% to 23% with a weighted average NOI debt yield of 12.2%. NOI debt yield ranged from 6% to 23%. There were 3 assets (7% of total balance) with NOI debt yield between 6% and 8%, 8 assets (14% of total balance) with NOI debt yield between 8% and 10%, 18 assets (51% of total balance) with NOI debt yield between 10% and 12%, 6 assets (12% of total balance) with NOI debt yield between 12% and 14%, 2 assets (1% of total balance) with NOI debt yield between 14% and 16%, 1 assets (1% of total balance) with NOI debt yield between 16% and 18%, 1 assets (9% of total balance) with NOI debt yield between 18% and 20%, 1 assets (2% of total balance) with NOI debt yield between 20% and 22% and 1 assets (4% of total balance) with NOI debt yield between 22% and 24%.

All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 5.0x. There were 16 assets (27.8% of total balance) with NCF DSCR between 1.0x and 1.5x, 14 assets (29.6% of total balance) with NCF DSCR between 1.5x and 2.0x, 6 assets (22.3% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (6.4% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (5.3% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (8.6% of total balance) with NCF DSCR between 4.5x and 5.0x. The most recent weighted average NCF DSCR was 2.1x.

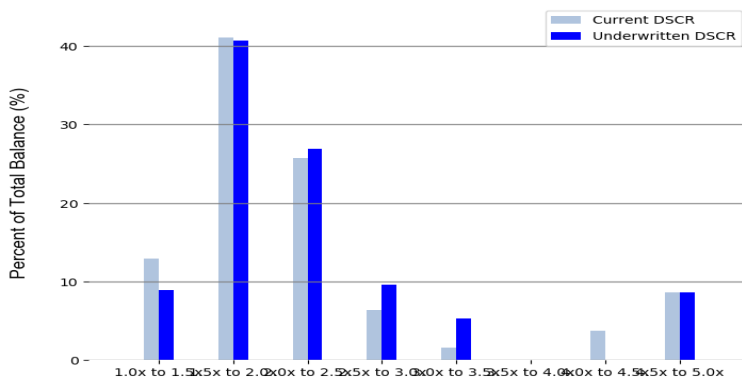

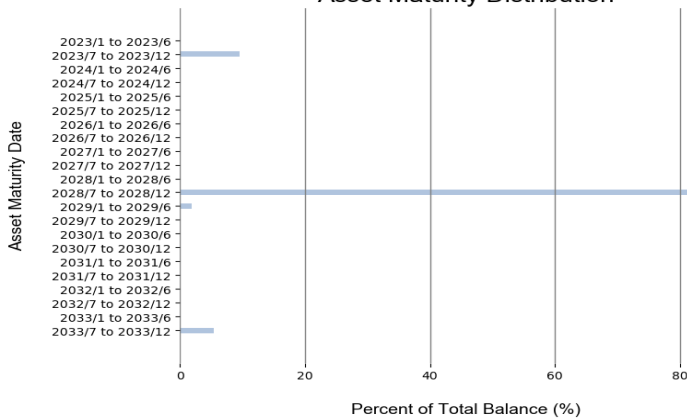
**DSCR Distribution (x)**



DSCRs ranged from 1.0x to 5.0x. There are 7 assets (12.9% of total balance) with DSCR between 1.0x and 1.5x, 19 assets (41.1% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (25.7% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (6.4% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (1.6% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (3.8% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (8.6% of total balance) with DSCR between 4.5x and 5.0x. The most recent weighted average DSCR is 2.2x.

There are 2 assets (9.6% of total balance) that have maturity dates between 2023/7 and 2023/12, 37 assets (83.1% of total balance) that have maturity dates between 2028/7 and 2028/12, 1 assets (1.8% of total balance) that have maturity dates between 2029/1 and 2029/6 and 1 assets (5.5% of total balance) that have maturity dates between 2029/7 and 2029/12.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
