Transaction Summary

The transaction closed on Jun 11 2014 and matures in Jul 2024. The pool's current aggregate principal balance is \$694.1 million compared to \$775.5 million at close.

The largest loan of the pool (15.9%) is secured by Woodbridge Center located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 67%. The major tenants included Sears (24.80%) and Boscov's (16.67%). The second largest loan of the pool (6.9%) is secured by Pacific Design Center located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 70%. The major tenants included Cedars-Sinai Medical Center (7.37%) and 8687 MELROSE GR TNT (5.44%). The third largest loan of the pool (4.4%) is secured by Purgatory Creek Apartments located in metropolitan area. Occupancy at the subject was 91%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.85% and 94 months as of 03/15/2022, respectively. There are a total of 69 loans and 169 properties in the portfolio. The appraisal LTV was approximately 95.5% compared to the Original loan to value (LTV), which was approximately 66.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.68x. As of 03/15/2022, 1.99% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 84%.

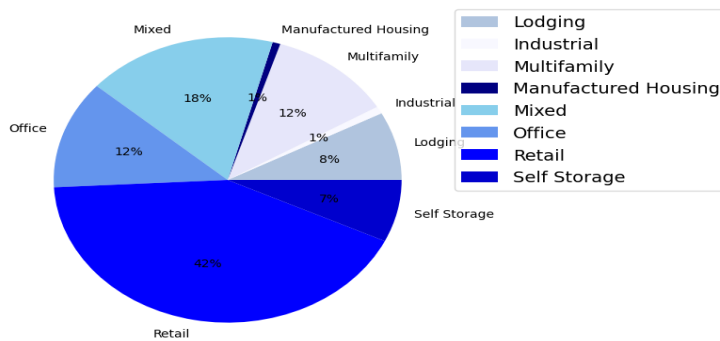

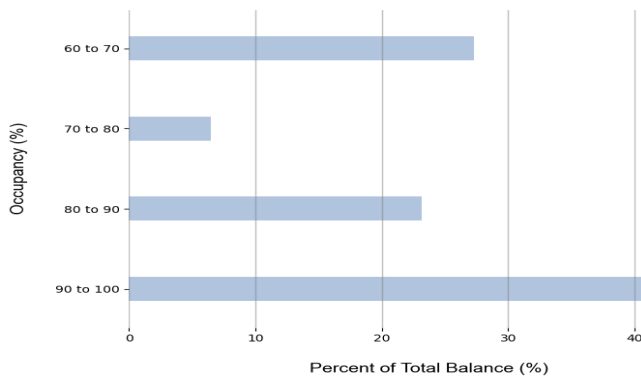

Occupancy Distribution (%)

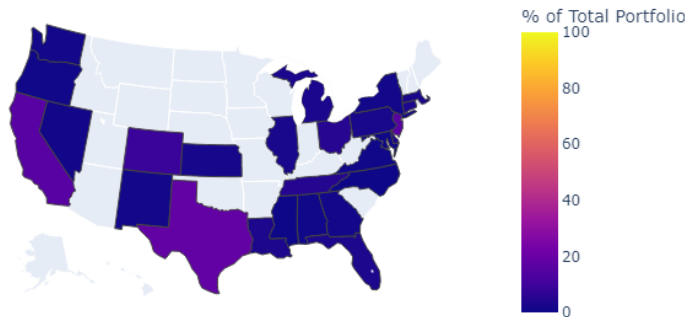

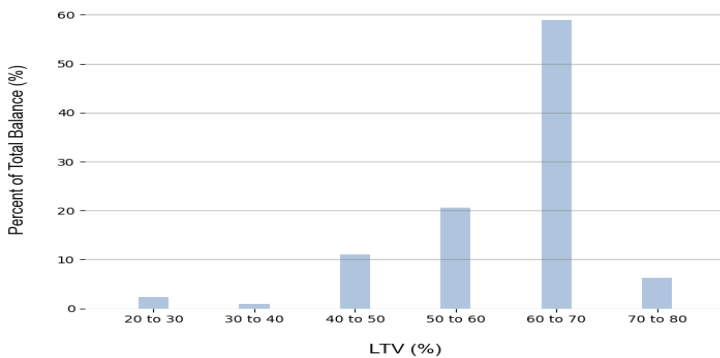
Local Distribution

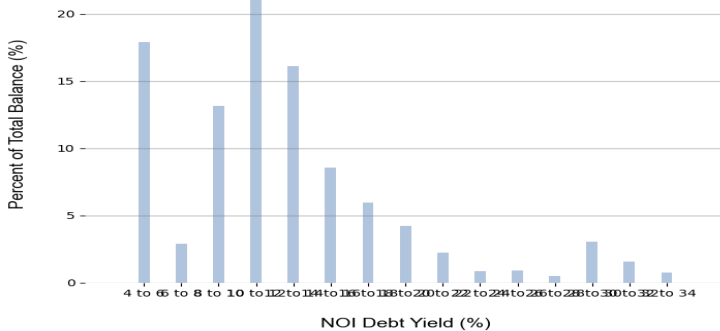

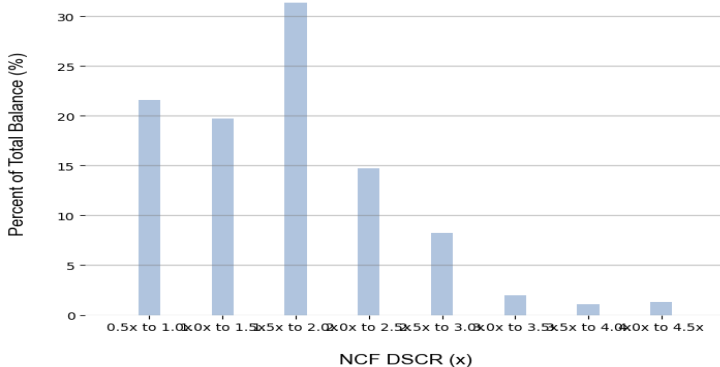
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 4% to 33% with a weighted average NOI debt yield of 12.6%. NOI debt yield ranged from 4% to 33%. Net Cash Flow DSCR (x)



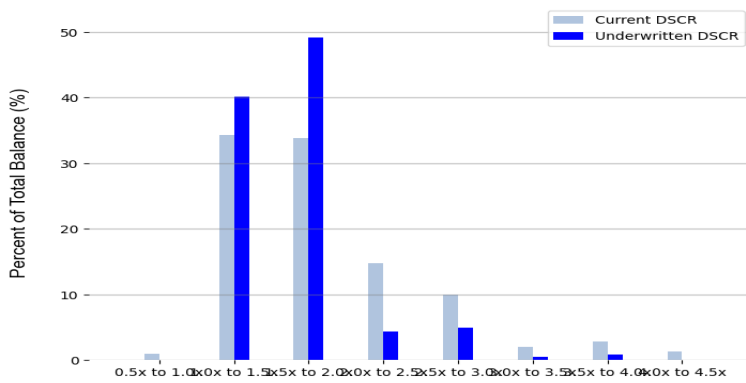

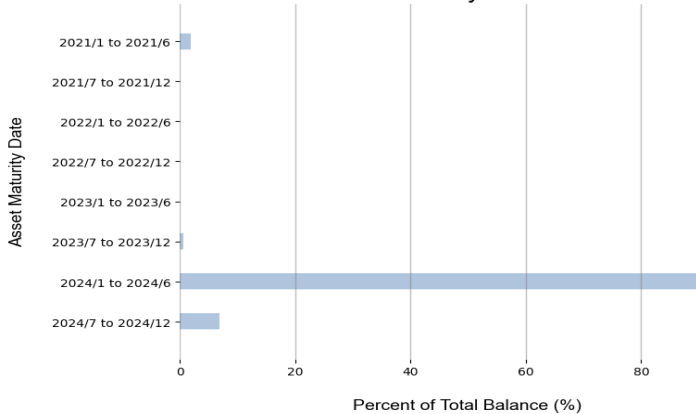
DSCR Distribution (x)

There are 2 assets (0.9% of total balance) with DSCR between 0.5x and 1.0x, 14 assets (34.4% of total balance) with DSCR between 1.0x and 1.5x, 24 assets (33.8% of total balance) with DSCR between 1.5x and 2.0x, 14 assets (14.8% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (10.0% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (2.0% of total balance) with DSCR between 3.0x and 3.5x, 4 assets (2.8% of total balance) with DSCR between 3.5x and 4.0x and 2 assets (1.3% of total balance) with DSCR between 4.0x and 4.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.


