Transaction Summary

The transaction closed on Jun 26 2015 and matures in Jun 2045. The pool's current aggregate principal balance is \$1074.9 million compared to \$1150.3 million at close.

The largest loan of the pool (8.9%) is secured by Hutchinson Metro Center I located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 99%. The major tenants included Mercy College (29.71%) and Administration of Childrens services (15.02%). The second largest loan of the pool (3.5%) is secured by Cathedral Place located in metropolitan area. Occupancy at the subject was 100%. The major tenants included HUSCH BLACKWELL LLP (42.69%) and Executive Director Inc (27.73%). The third largest loan of the pool (3.5%) is secured by 150 Royall Street located in Boston, MA metropolitan area. Occupancy at the subject was 100%. The major tenants included Computershare (23.72%) and CB & I Inc. (16.66%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.25% and 68 months as of 01/15/2021, respectively. There are a total of 128 loans and 146 properties in the portfolio. The appraisal LTV was approximately 60.9% compared to the Original loan to value (LTV), which was approximately 64.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.83x. As of 01/15/2021, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.

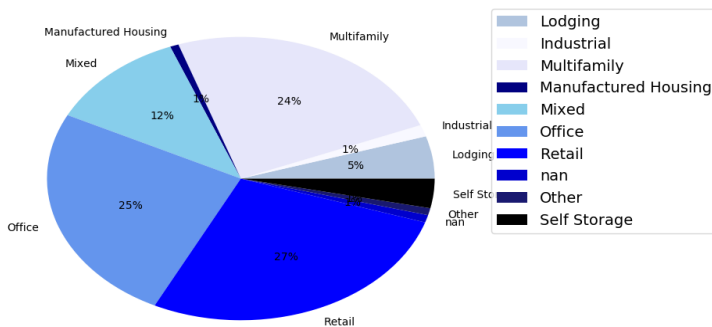

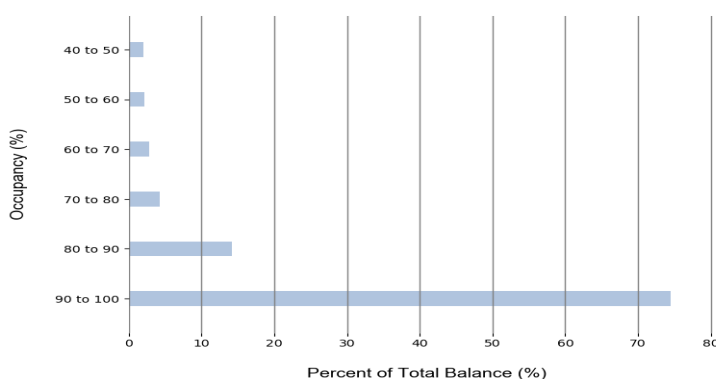

Occupancy Distribution (%)

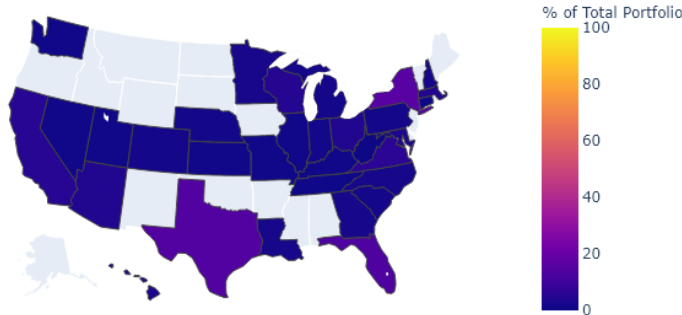

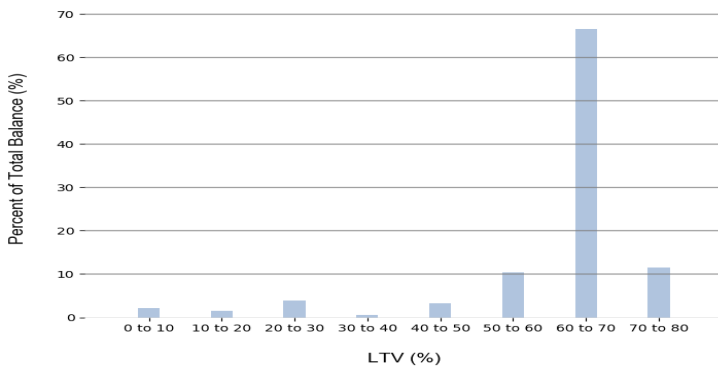
Local Distribution

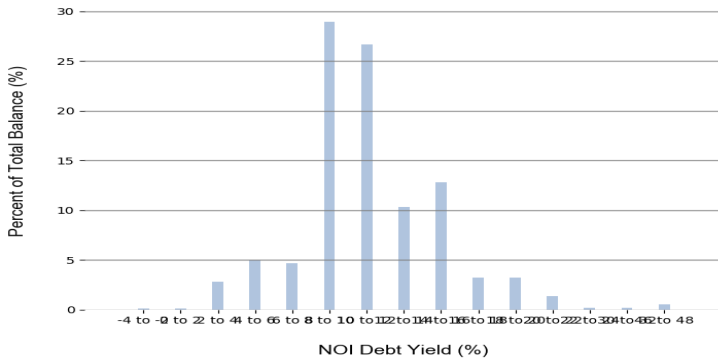

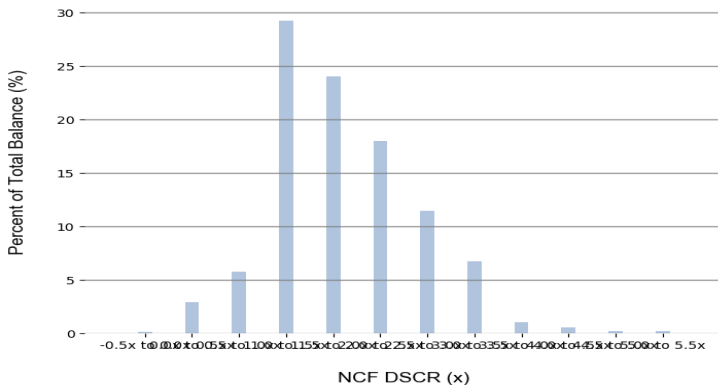
NOI Debt Yield (%)

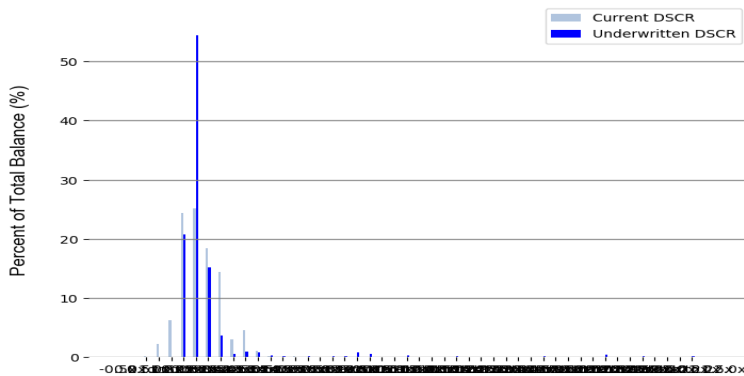

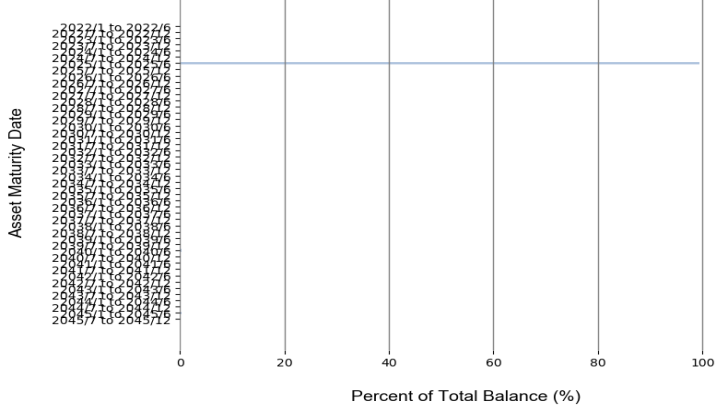
DSCR Distribution (x)

DSCRs ranged from -0.5x to 6.0x. There are 1 assets (0.1% of total balance) with DSCR between -0.5x and 0.0x, 4 assets (2.3% of total balance) with DSCR between 0.0x and 0.5x, 10 assets (6.3% of total balance) with DSCR between 0.5x and 1.0x, 27 assets (24.3% of total balance) with DSCR between 1.0x and 1.5x, 33 assets (25.2% of total balance) with DSCR between 1.5x and 2.0x, 31 assets (18.4% of total balance) with DSCR between 2.0x and 2.5x, 12 assets (14.5% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (3.0% of total balance) with DSCR between 3.0x and 3.5x, 3 assets (4.5% of total balance) with DSCR between 3.5x and 4.0x, 3 assets (1.1% of total balance) with DSCR between 4.0x and 4.5x, 1 assets (0.2% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (0.1% of total balance) with DSCR between 5.5x and 6.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

There are three notches in each of EJR's rating categories (e.g., A-(sf), A(sf) and A+(sf) for category A(sf)) except for AAA(sf), CC(sf), C(sf) and D(sf).

2. The version of the procedure or methodology used to determine the credit rating as required by Paragraph (a)(1)(ii)(B) of Rule 17g-7:

We are using the Methodology for Rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) v1a and General Methodology for Rating Asset Backed and Structured Finance Obligations (Non-NRSRO) v1.

3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:

- 1). Are not intended to address the value, price, price stability, liquidity, suitability, or merit of an investment.
- 2). Do not address whether a particular rated security is suitable for a particular investor or suitable for an investor's risk tolerance.
- 3). Do not address whether the expected return of a particular investment is adequate for the inherent risk.
- 4). Do not address whether the market value of the security will remain stable over time.
- 5). Are not exact measures of the probability of default but are instead expressions of the relative credit risk of issuers and debt instruments.
