Transaction Summary

The transaction closed on Aug 12 2015 and matures in Jul 2035. The pool's current aggregate principal balance is \$680.9 million compared to \$726.4 million at close.

The largest loan of the pool (10.8%) is secured by Somerset Park Apartments located in Warren-Troy-Farmington Hills, MI metropolitan area. Occupancy at the subject was 94%. The second largest loan of the pool (8.3%) is secured by Riverpark Square located in metropolitan area. Occupancy at the subject was 96%. The major tenants included Nordstrom (34.44%) and AMC Cinema (21.58%). The third largest loan of the pool (5.7%) is secured by Simmons Tower located in metropolitan area. Occupancy at the subject was 79%. The major tenants included Energy Security Cushman and Wakefield (26.76%) and Mitchell Williams Office Se (7.83%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.53% and 65 months as of 12/15/2020, respectively. There are a total of 95 loans and 105 properties in the portfolio. The appraisal LTV was approximately 61.3% compared to the Original loan to value (LTV), which was approximately 62.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.70x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.

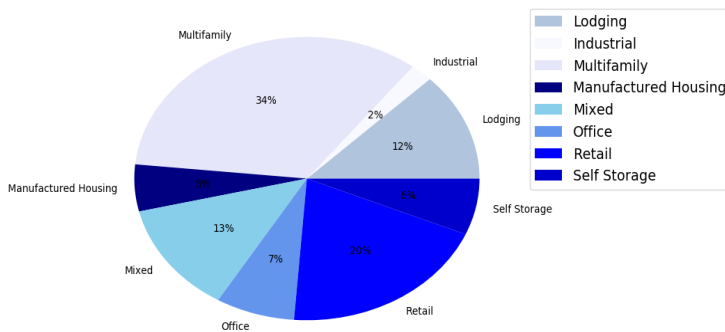

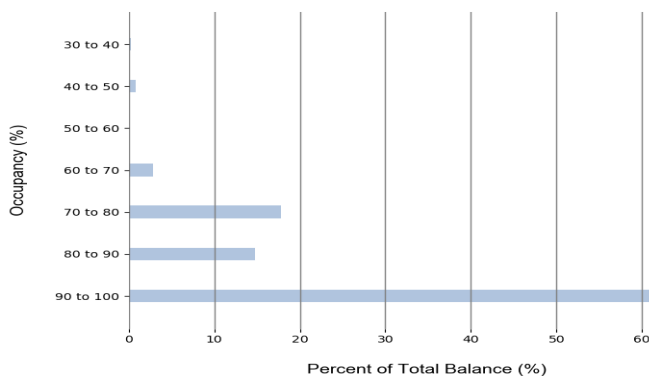

Occupancy Distribution (%)

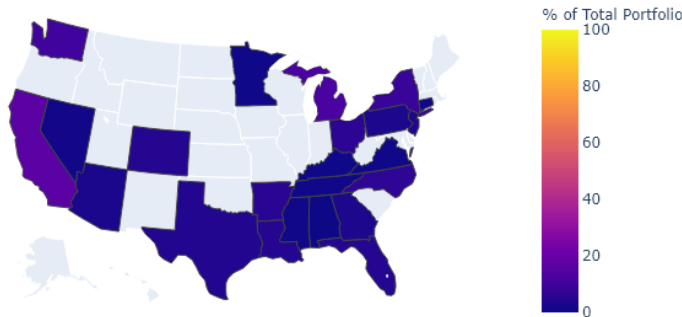

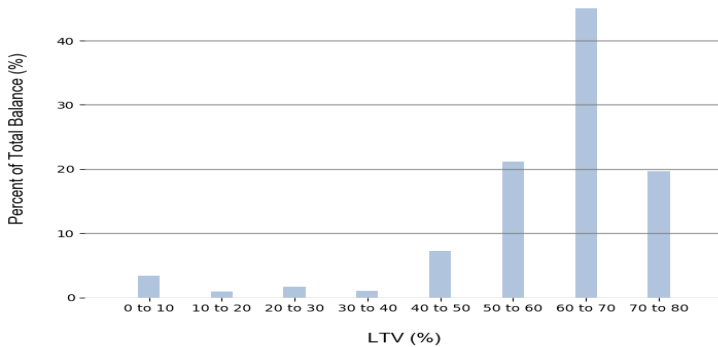
Local Distribution

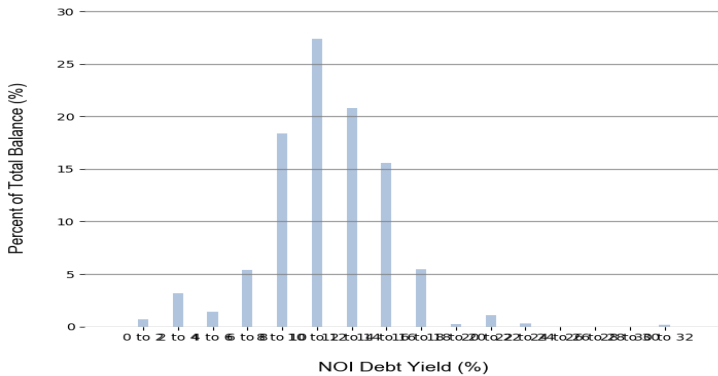

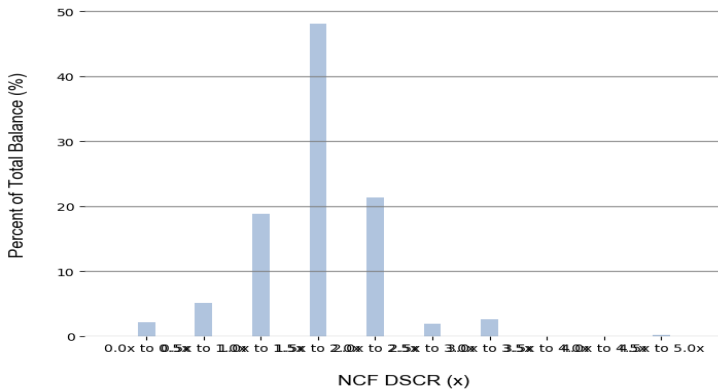
NOI Debt Yield (%)

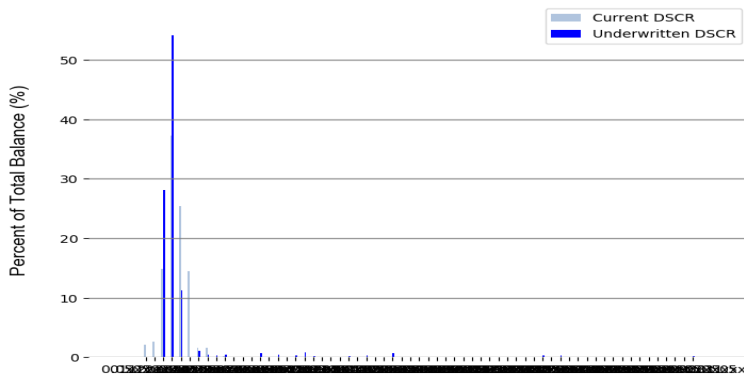

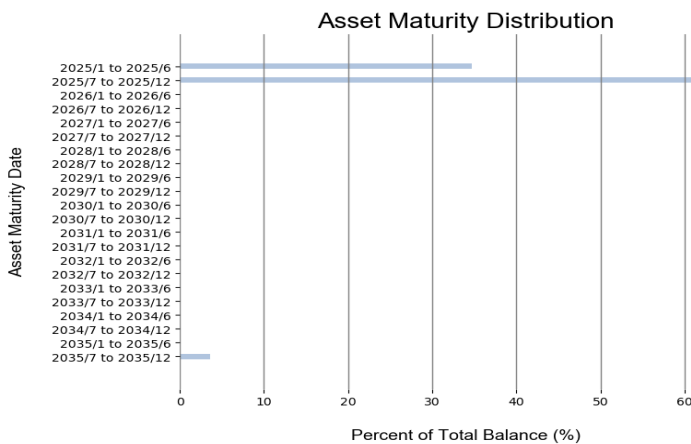

There are 5 assets (2.1% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (2.6% of total balance) with DSCR between 0.5x and 1.0x, 21 assets (14.9% of total balance) with DSCR between 1.0x and 1.5x, 32 assets (37.3% of total balance) with DSCR between 1.5x and 2.0x, 20 assets (25.4% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (14.4% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (1.5% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (1.6% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (0.2% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
