Transaction Summary

The transaction closed on Nov 12 2015 and matures in Sep 2026. The pool's current aggregate principal balance is \$917.7 million compared to \$956.2 million at close.

The largest loan of the pool (7.6%) is secured by 745 Atlantic Avenue located in Boston, MA metropolitan area. Occupancy at the subject was 99%. The major tenants included WW 745 Atlantic (75.29%) and CAMBRIDGE ASSOCIATES LLC (17.67%). The second largest loan of the pool (6.5%) is secured by Sheraton Lincoln Harbor Hotel located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 89%. The third largest loan of the pool (4.9%) is secured by CityPlace I located in metropolitan area. Occupancy at the subject was 85%. The major tenants included United HealthCare (42.44%) and Bank Of America (7.46%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.62% and 60 months as of 10/15/2020, respectively. There are a total of 94 loans and 107 properties in the portfolio. The appraisal LTV was approximately 64.2% compared to the Original loan to value (LTV), which was approximately 66.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.85x. As of 10/15/2020, 0.57% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.

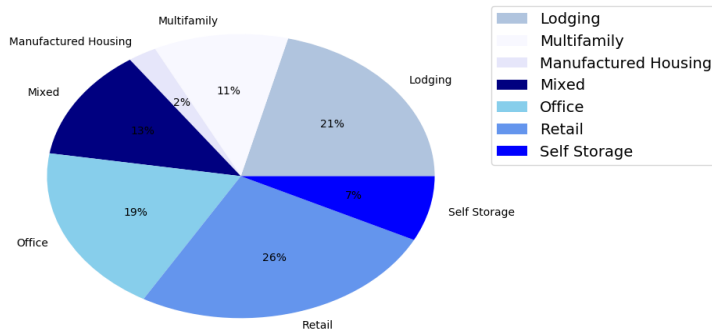

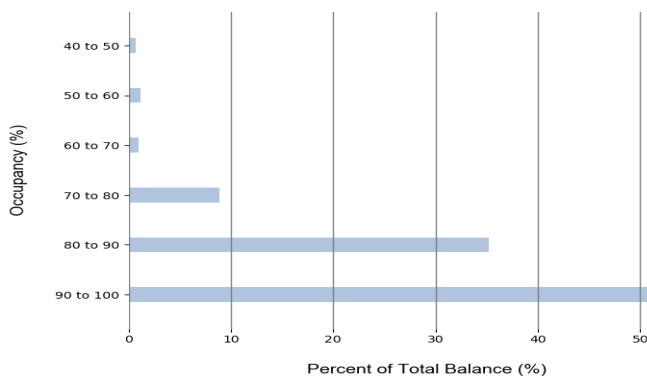

Occupancy Distribution (%)

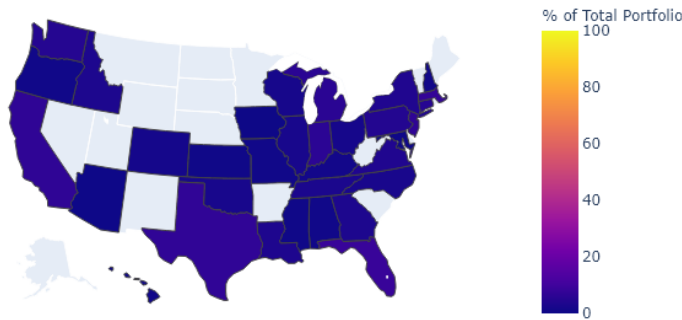

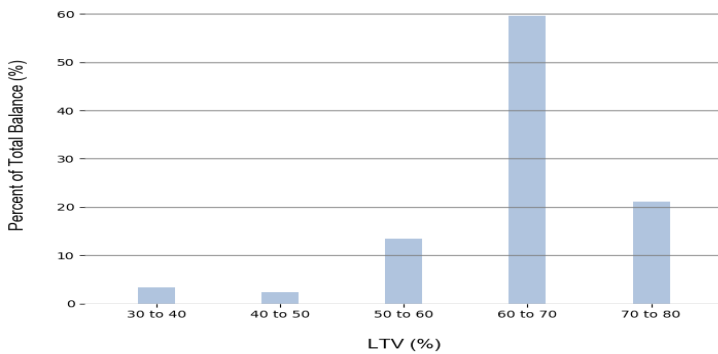
Local Distribution

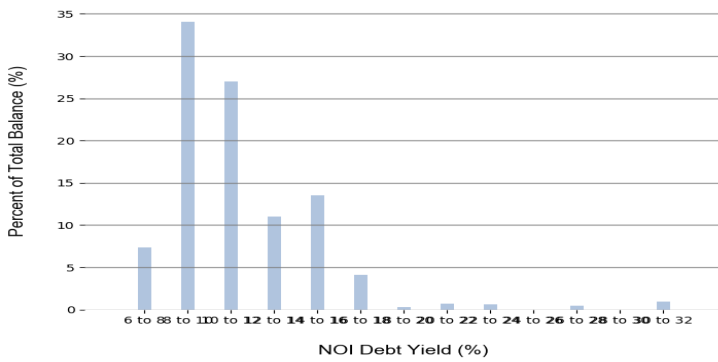

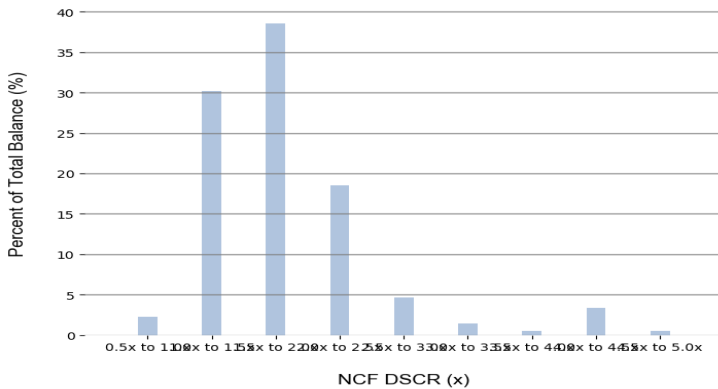
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

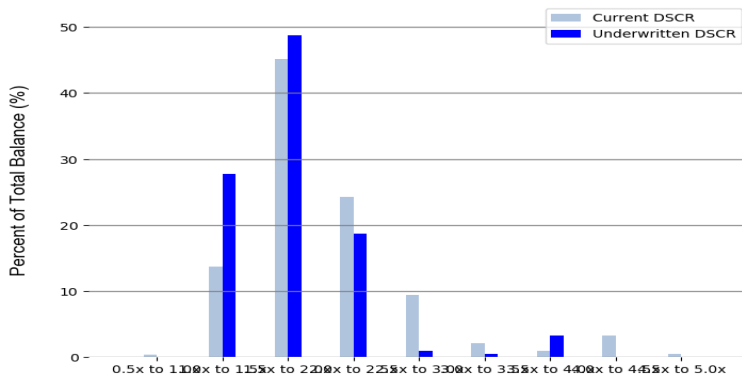

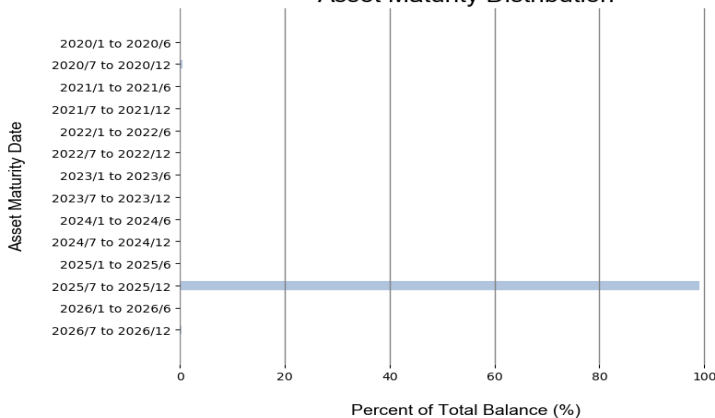
DSCR Distribution (x)



DSCRs ranged from 0.5x to 5.0x. There are 1 assets (0.3% of total balance) with DSCR between 0.5x and 1.0x, 17 assets (13.7% of total balance) with DSCR between 1.0x and 1.5x, 41 assets (45.2% of total balance) with DSCR between 1.5x and 2.0x, 18 assets (24.3% of total balance) with DSCR between 2.0x and 2.5x, 11 assets (9.5% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (2.2% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (0.9% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (3.3% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (0.5% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
