Transaction Summary

The transaction closed on Oct 13 2015 and matures in Oct 2025. The pool's current aggregate principal balance is \$554.5 million compared to \$580.7 million at close.

The largest loan of the pool (10.8%) is secured by Yosemite Resorts located in metropolitan area. Occupancy at the subject was 69%. The second largest loan of the pool (11.7%) is secured by Northline Commons located in metropolitan area. Occupancy at the subject was 96%. The major tenants included Burlington Coat Factory (14.92%) and Conn's Appliance (9.31%). The third largest loan of the pool (8.2%) is secured by Hilton Nashville located in metropolitan area. Occupancy at the subject was 92%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.52% and 63 months as of 12/15/2020, respectively. There are a total of 49 loans and 52 properties in the portfolio. The appraisal LTV was approximately 57.5% compared to the Original loan to value (LTV), which was approximately 58.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.23x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.

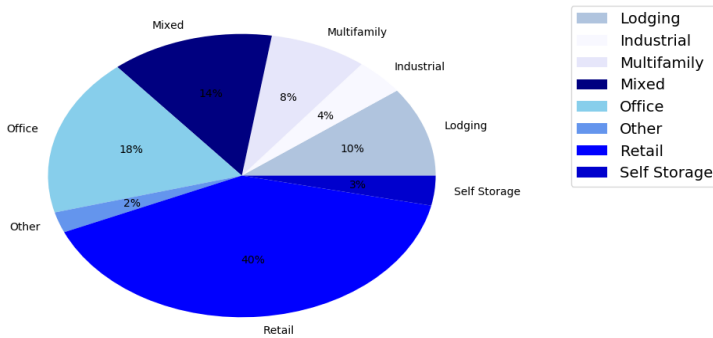

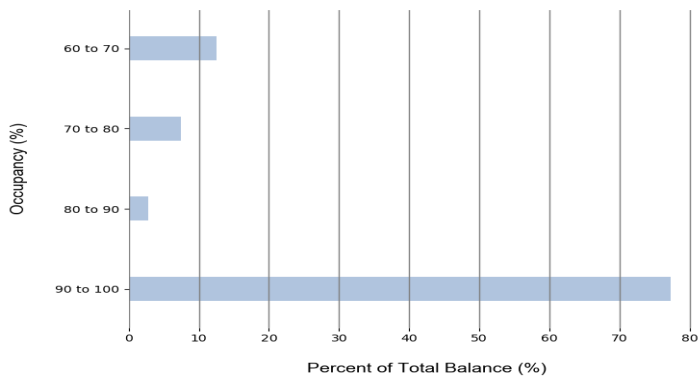

Occupancy Distribution (%)

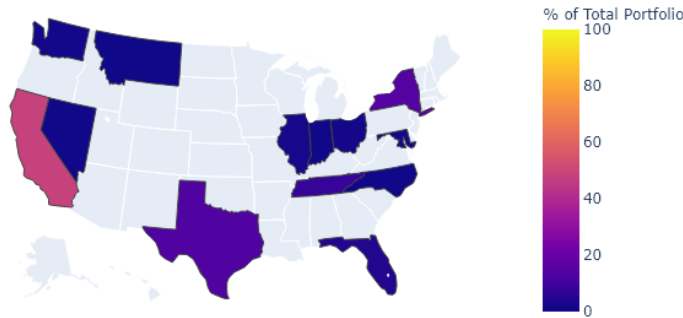

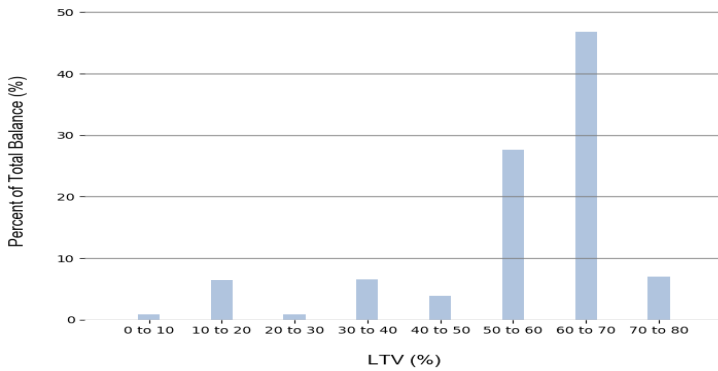
Local Distribution

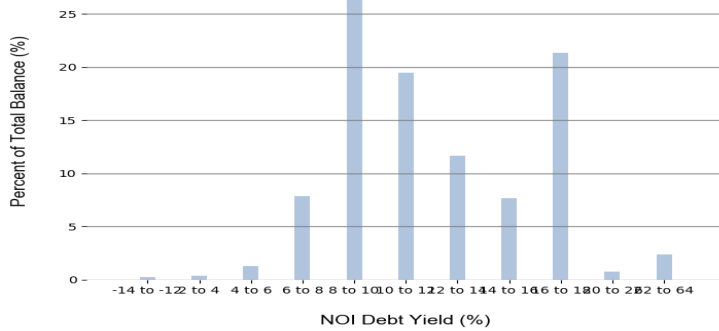

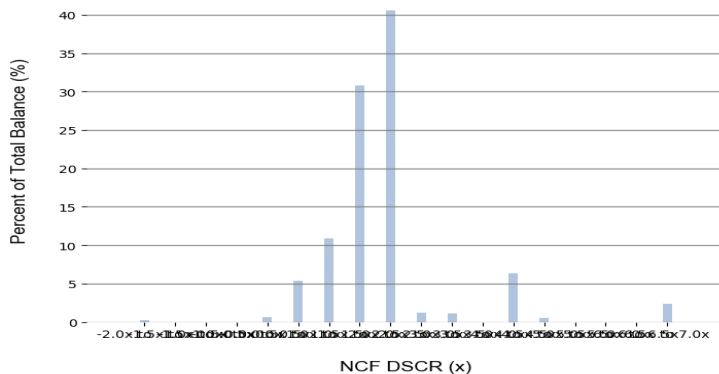
NOI Debt Yield (%)

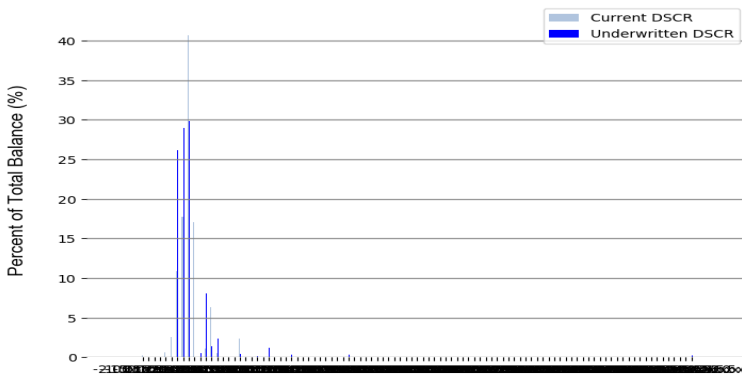

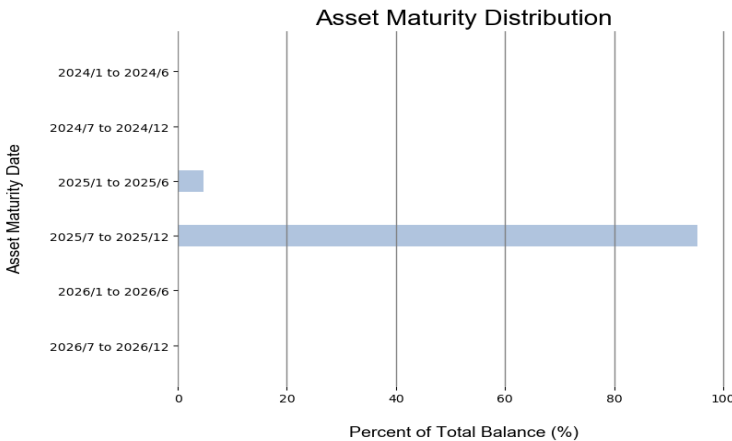

There are 1 assets (0.2% of total balance) with DSCR between -2.0x and -1.5x, 1 assets (0.6% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (2.5% of total balance) with DSCR between 0.5x and 1.0x, 9 assets (10.8% of total balance) with DSCR between 1.0x and 1.5x, 12 assets (17.8% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (40.6% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (17.1% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (1.1% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (6.3% of total balance) with DSCR between 4.0x and 4.5x, 1 assets (0.5% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (2.4% of total balance) with DSCR between 6.5x and 7.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
