Transaction Summary

The transaction closed on Nov 03 2016 and matures in Nov 2026. The pool's current aggregate principal balance is \$779.1 million compared to \$828.0 million at close.

The largest loan of the pool (9.6%) is secured by Gurnee Mills located in Lake County-Kenosha County, IL-WI metropolitan area. Occupancy at the subject was 87%. The major tenants included Bass Pro Shops (8.15%) and Macy's (7.72%). The second largest loan of the pool (8.7%) is secured by 101 Hudson Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 74%. The major tenants included Merrill Lynch (28.94%) and FIRST DATA CORPORATION (5.99%). The third largest loan of the pool (8.3%) is secured by Plaza America I & II located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 86%. The major tenants included SOFTWARE AG GOVT SOLUTIONS INC (12.05%) and NVR, Inc. (11.88%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.20% and 66 months as of 03/15/2022, respectively. There are a total of 69 loans and 100 properties in the portfolio. The appraisal LTV was approximately 57.4% compared to the Original loan to value (LTV), which was approximately 59.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.62x. As of 03/15/2022, 0.54% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 82%.

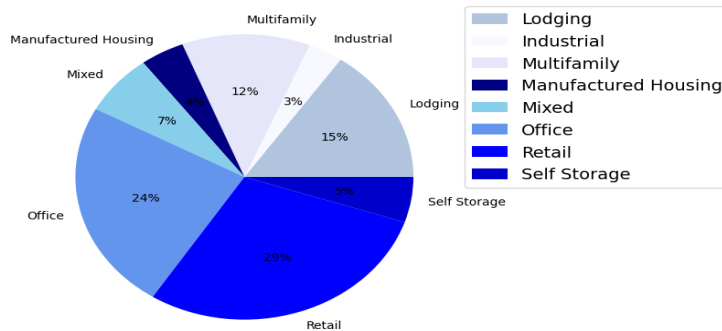

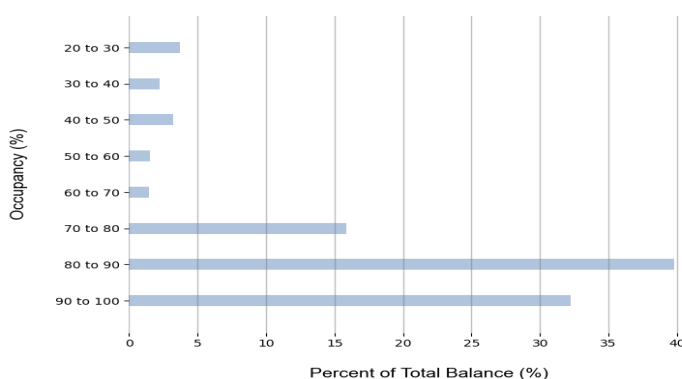

Occupancy Distribution (%)

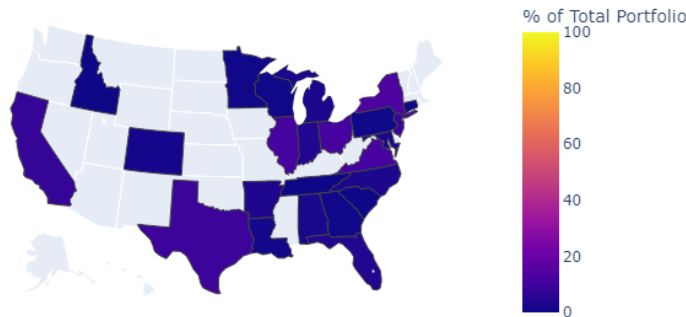

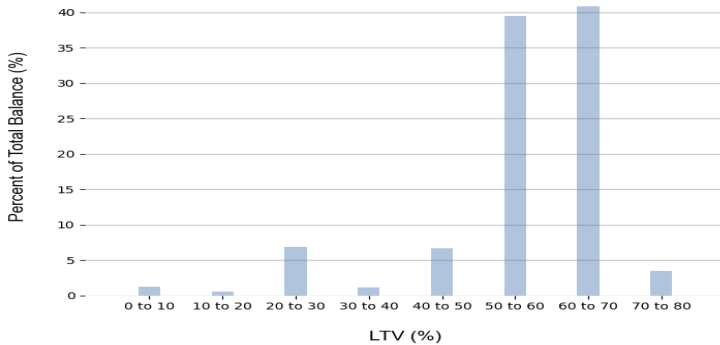
Local Distribution



Among assets in the portfolio, there are 13 properties (13% of total balance) located in New York, 4 properties (11% of total balance) in Illinois, 3 properties (11% of total balance) in Virginia, 10 properties (11% of total balance) in Ohio, 19 properties (9% of total balance) in Texas, 1 property (9% of total balance) in New Jersey, 7 properties (8% of total balance) in California and 6 properties (4% of total balance) in Florida. Other properties are located in the state of Indiana, Arkansas, North Carolina, Michigan, Maryland, Alabama, Colorado, Louisiana, Georgia, Wisconsin, Minnesota, Pennsylvania, Connecticut, South Carolina, Tennessee and Idaho.

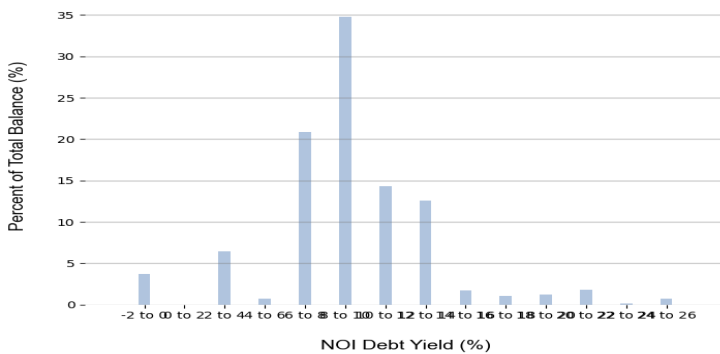

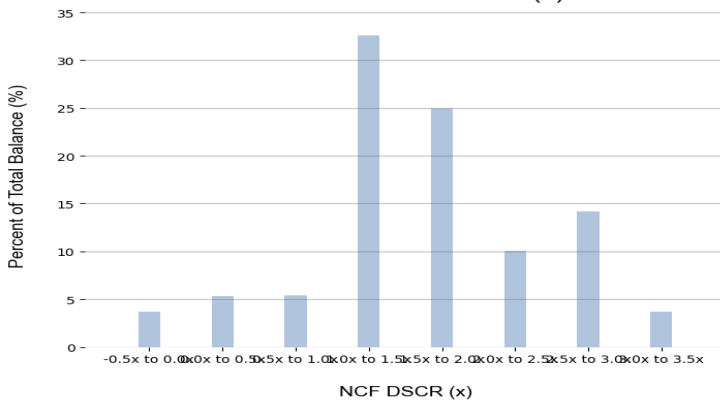
NOI Debt Yield (%)

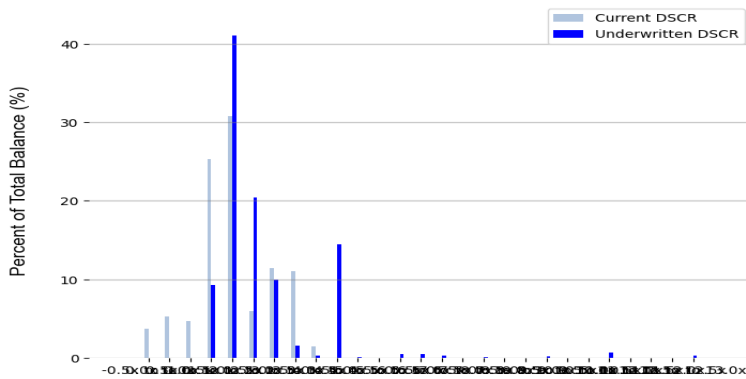
Net Cash Flow DSCR (x)

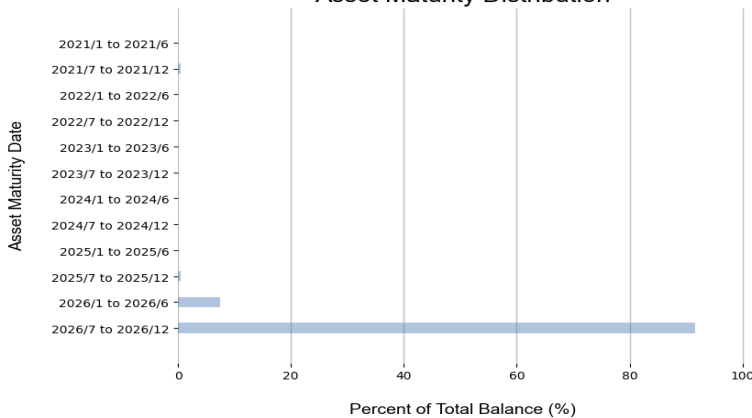
DSCR Distribution (x)

There are 1 assets (3.7% of total balance) with DSCR between -0.5x and 0.0x, 3 assets (5.3% of total balance) with DSCR between 0.0x and 0.5x, 5 assets (4.8% of total balance) with DSCR between 0.5x and 1.0x, 16 assets (25.3% of total balance) with DSCR between 1.0x and 1.5x, 23 assets (30.8% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (6.0% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (11.5% of total balance) with DSCR between 2.5x and 3.0x, 6 assets (11.1% of total balance) with DSCR between 3.0x and 3.5x and 2 assets (1.5% of total balance) with DSCR between 3.5x and 4.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:


