Transaction Summary

The transaction closed on Jul 13 2017 and matures in Apr 2028. The pool's current aggregate principal balance is \$1115.7 million compared to \$1139.4 million at close.

The largest loan of the pool (10.3%) is secured by General Motors Building located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 96%. The major tenants included Weil, Gotshal & Manges (24.62%) and Aramis (15.07%). The second largest loan of the pool (5.4%) is secured by Del Amo Fashion Center located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 85%. The major tenants included J.C. Penney (9.23%) and Nordstrom (7.80%). The third largest loan of the pool (4.9%) is secured by 245 Park Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 92%. The major tenants included Societe Generale (32.62%) and JPMorgan Chase Bank, N.A. (13.08%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.35% and 42 months as of 12/15/2020, respectively. There are a total of 75 loans and 177 properties in the portfolio. The appraisal LTV was approximately 54.9% compared to the Original loan to value (LTV), which was approximately 55.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.29x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.

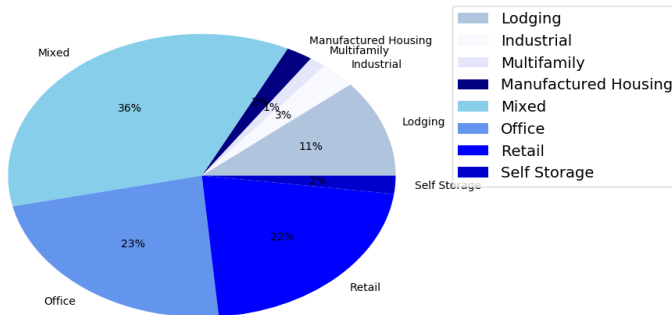

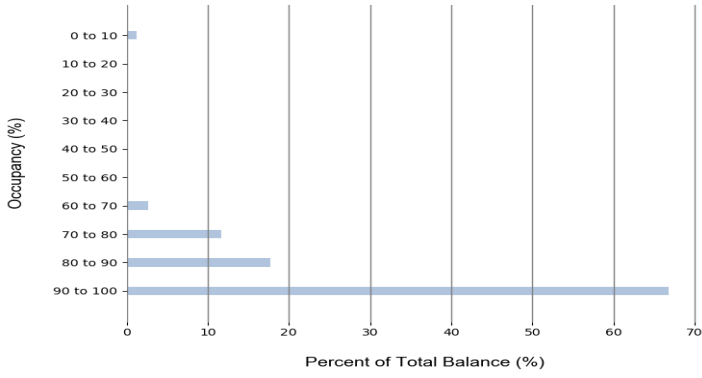

Occupancy Distribution (%)

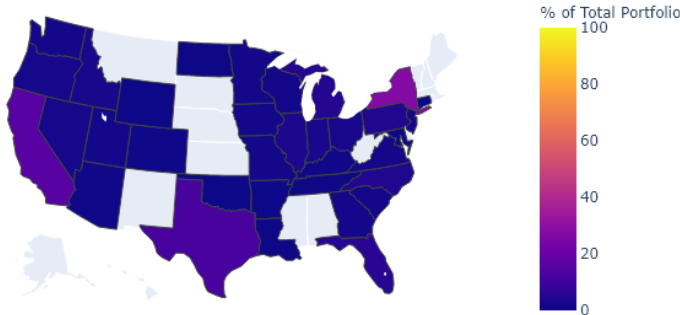

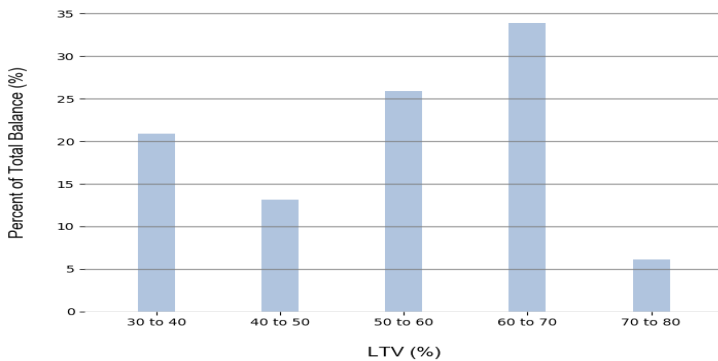
Local Distribution



Among assets in the portfolio, there are 9 properties (27% of total balance) located in New York, 21 properties (16% of total balance) in California, 35 properties (12% of total balance) in Texas, 6 properties (5% of total balance) in Florida, 9 properties (5% of total balance) in Michigan, 9 properties (4% of total balance) in Pennsylvania, 4 properties (4% of total balance) in North Carolina and 9 properties (3% of total balance) in Illinois. 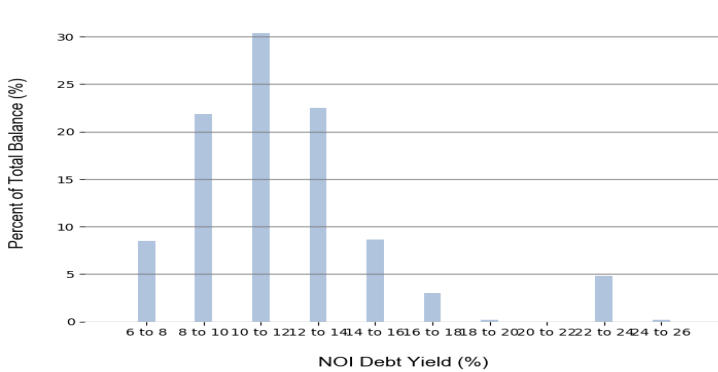

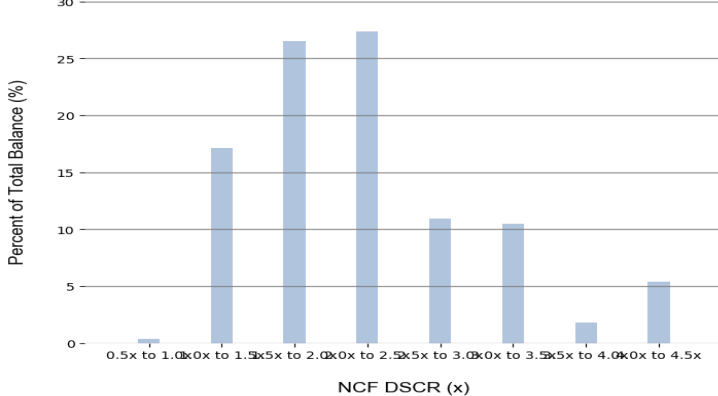
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

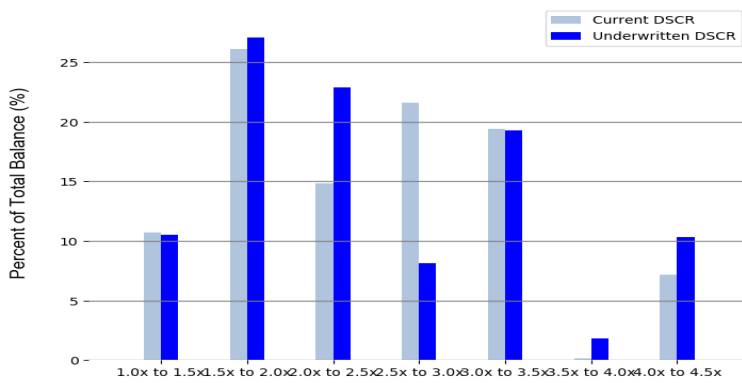


NCF DSCR ranged from 0.0x to 4.0x. There were 1 assets (0.4% of total balance) with NCF DSCR between 0.5x and 1.0x, 22 assets (17.1% of total balance) with NCF DSCR between 1.0x and 1.5x, 29 assets (26.5% of total balance) with NCF DSCR between 1.5x and 2.0x, 14 assets (27.4% of total balance) with NCF DSCR between 2.0x and 2.5x, 5 assets (10.9% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (10.5% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (1.8% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (5.4% of total balance) with NCF DSCR between 4.0x and 4.5x. 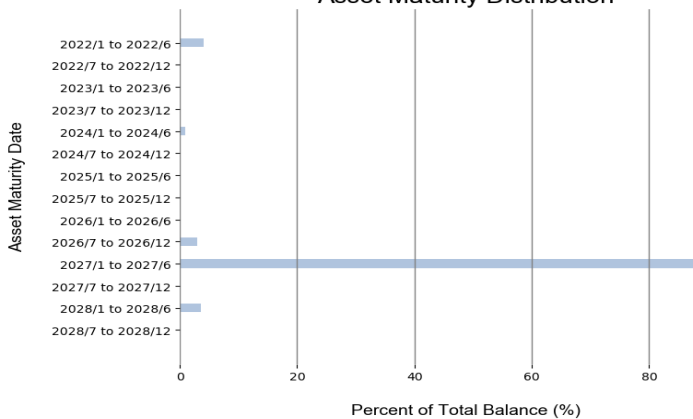
DSCR Distribution (x)



DSCRs ranged from 1.0x to 4.5x. There are 15 assets (10.7% of total balance) with DSCR between 1.0x and 1.5x, 31 assets (26.1% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (14.8% of total balance) with DSCR between 2.0x and 2.5x, 10 assets (21.6% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (19.4% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.2% of total balance) with DSCR between 3.5x and 4.0x and 2 assets (7.2% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 2.5x.

There are 3 assets (4.0% of total balance) that have maturity dates between 2022/1 and 2022/6, 1 assets (0.8% of total balance) that have maturity dates between 2024/1 and 2024/6, 1 assets (3.0% of total balance) that have maturity dates between 2026/7 and 2026/12, 69 assets (88.5% of total balance) that have maturity dates between 2027/1 and 2027/6 and 1 assets (3.6% of total balance) that have maturity dates between 2028/1 and 2028/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
