## Transaction Summary

The transaction closed on Dec 21 2017 and matures in Dec 2029. The pool's current aggregate principal balance is \$737.9 million compared to \$744.9 million at close.

The largest loan of the pool (9.5%) is secured by One Ally Center located in Detroit-Dearborn-Livonia, MI metropolitan area. Occupancy at the subject was 96%. The major tenants included ALLY FINANCIAL INC (33.73%) and Clark Hill PLC (7.88%). The second largest loan of the pool (9.0%) is secured by 16 Court Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 88%. The major tenants included City of New York (14.49%) and Michael Van Valkenburgh Assoc. (7.66%). The third largest loan of the pool (7.5%) is secured by Logan Town Center located in metropolitan area. Occupancy at the subject was 99%. The major tenants included Boscov's (26.54%) and Kohl's Department Store (12.31%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.40% and 35 months as of 10/15/2020, respectively. There are a total of 37 loans and 66 properties in the portfolio. The appraisal LTV was approximately 60.8% compared to the Original loan to value (LTV), which was approximately 59.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.49x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.

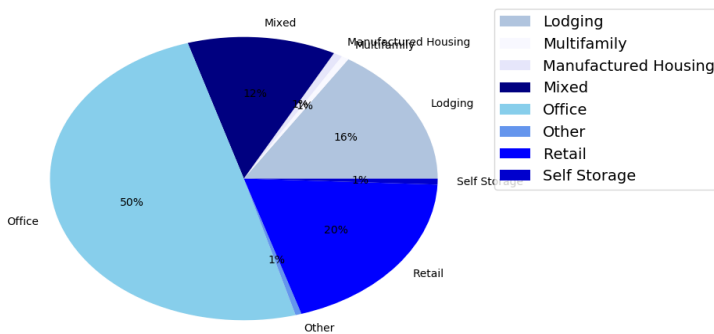

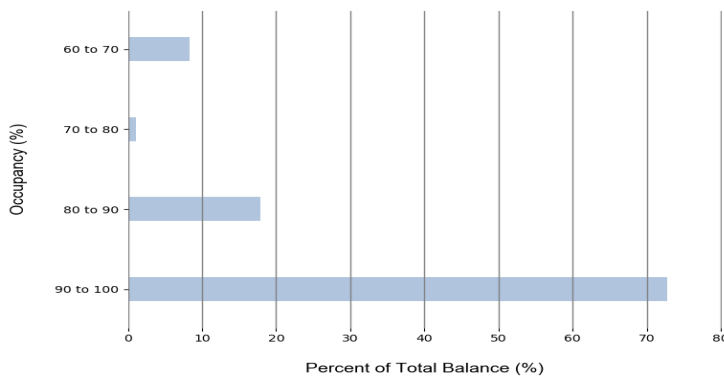

Occupancy Distribution (%)

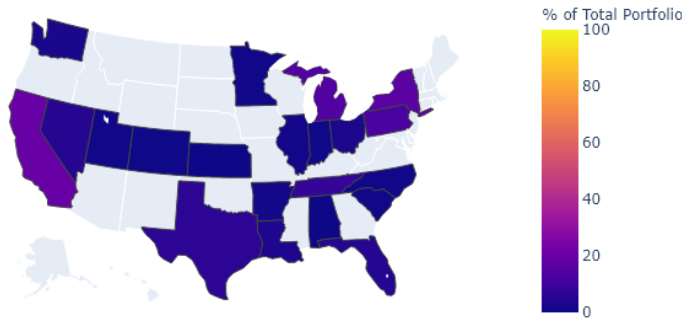

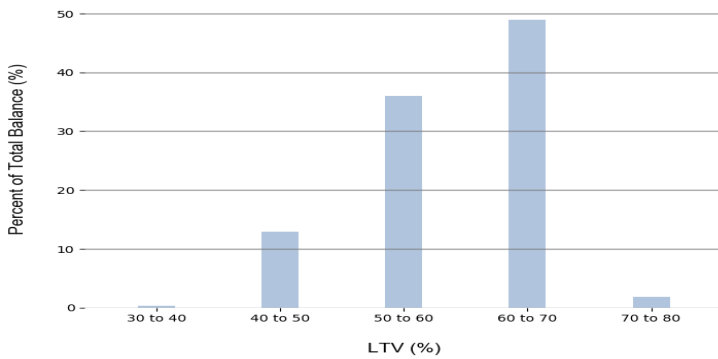
Local Distribution

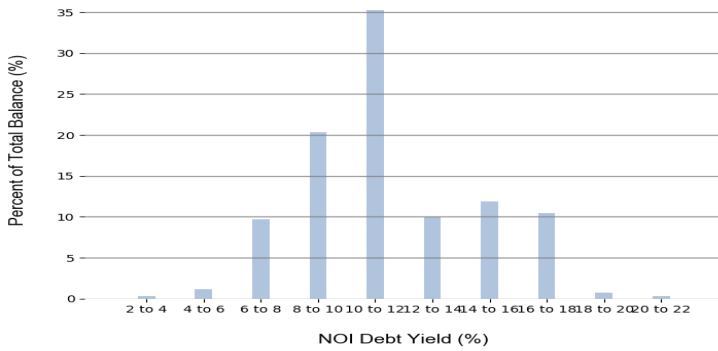

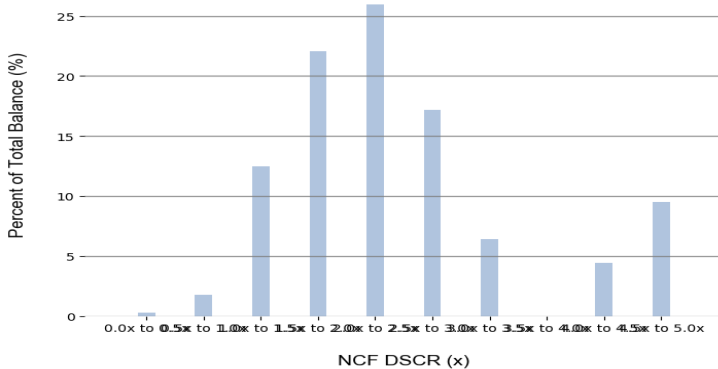
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 2% to 21% with a weighted average NOI debt yield of 11.7%. NOI debt yield ranged from 2% to 21%. There were 1 assets (0% of total balance) with NOI debt yield between 2% and 4%, 2 assets (1% of total balance) with NOI debt yield between 4% and 6%, 2 assets (10% of total balance) with NOI debt yield between 6% and 8%, 10 assets (20% of total balance) with NOI debt yield between 8% and 10%, 10 assets (35% of total balance) with NOI debt yield between 10% and 12%, 4 assets (10% of total balance) with NOI debt yield between 12% and 14%, 3 assets (12% of total balance) with NOI debt yield between 14% and 16%, 3 assets (10% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 18% and 20% and 1 assets (0% of total balance) with NOI debt yield between 20% and 22%.

Net Cash Flow DSCR (x)

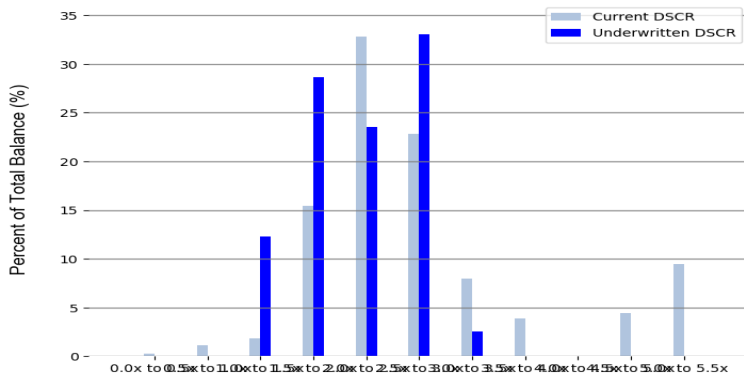

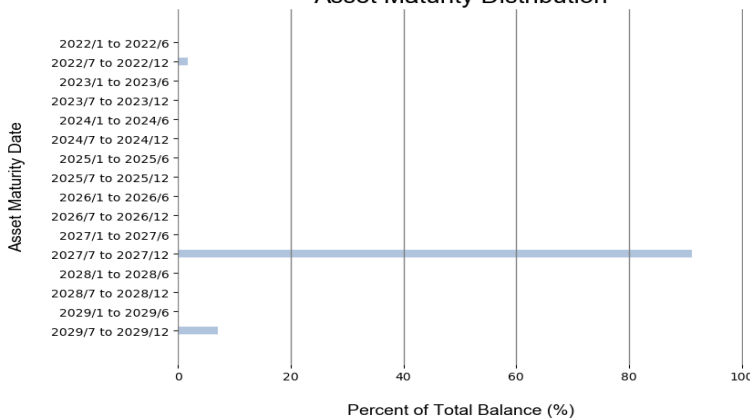
**DSCR Distribution (x)**



DSCRs ranged from 0.0x to 5.5x. There are 1 assets (0.3% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (1.1% of total balance) with DSCR between 0.5x and 1.0x, 3 assets (1.8% of total balance) with DSCR between 1.0x and 1.5x, 7 assets (15.4% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (32.8% of total balance) with DSCR between 2.0x and 2.5x, 8 assets (22.8% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (7.9% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (3.9% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (4.4% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (9.5% of total balance) with DSCR between 5.0x and 5.5x. There are 2 assets (1.7% of total balance) that have maturity dates between 2022/7 and 2022/12, 1 assets (0.2% of total balance) that have maturity dates between 2026/7 and 2026/12, 32 assets (91.1% of total balance) that have maturity dates between 2027/7 and 2027/12 and 2 assets (7.0% of total balance) that have maturity dates between 2029/7 and 2029/12.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
