Transaction Summary

The transaction closed on Nov 07 2019 and matures in Jun 2034. The pool's current aggregate principal balance is \$699.9 million compared to \$702.5 million at close.

The largest loan of the pool (8.6%) is secured by Equinix Data Center located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was Equinix (100.00%). The second largest loan of the pool (6.5%) is secured by Ceasar's Bay Shopping Center located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 98%. The major tenants included Kohl's Department Store (39.74%) and Target (29.21%). The third largest loan of the pool (6.4%) is secured by Planet Self Storage Portfolio located in Montgomery County-Bucks County-Chester County, PA-16.83% Cambridge-Newton-Framingham, MA-13.00% Boston, MA-8.71% Newark, NJ-PA-6.86% Camden, NJ-PA-6.43% metropolitan area. Occupancy at the subject was 85%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.96% and 15 months as of 12/15/2020, respectively. There are a total of 58 loans and 85 properties in the portfolio. The appraisal LTV was approximately 62.5% compared to the Original loan to value (LTV), which was approximately 62.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.37x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.

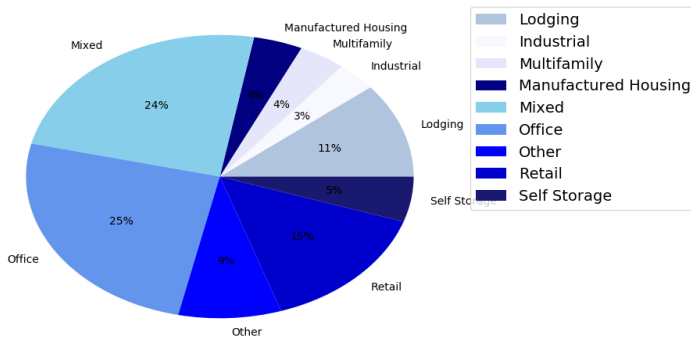

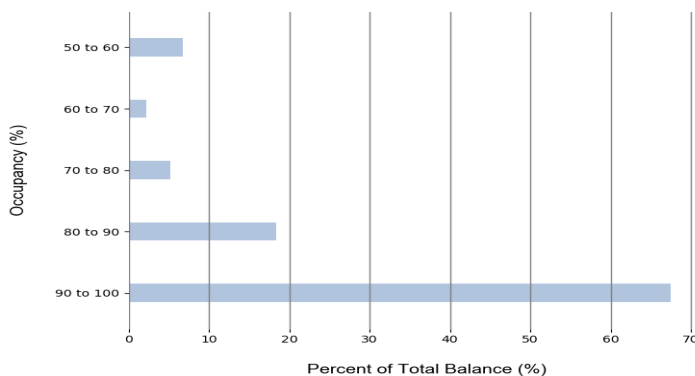

Occupancy Distribution (%)

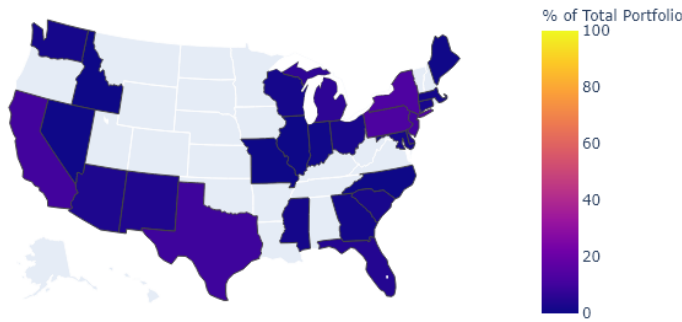

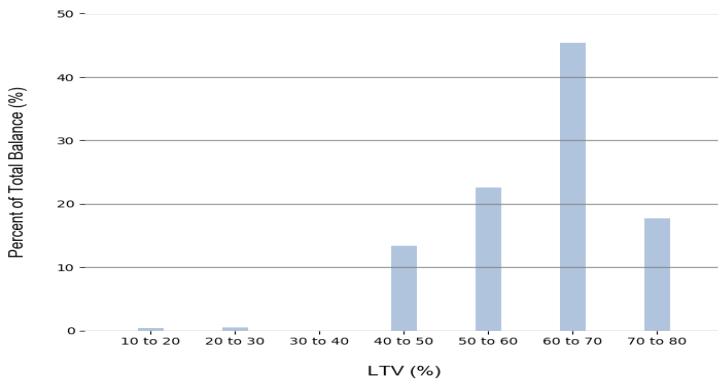
Local Distribution

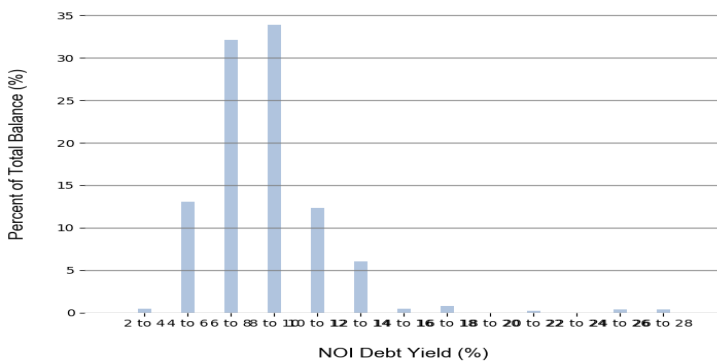

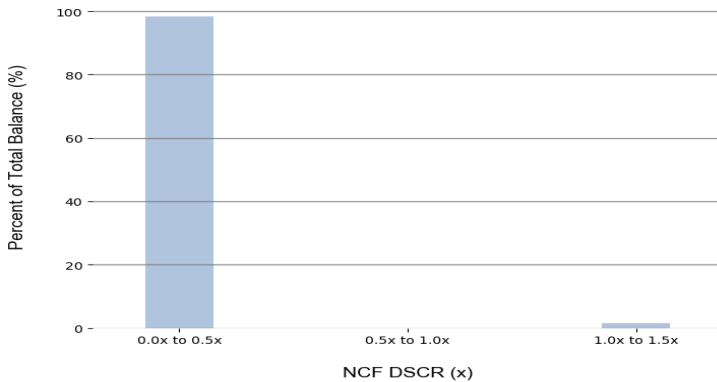
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

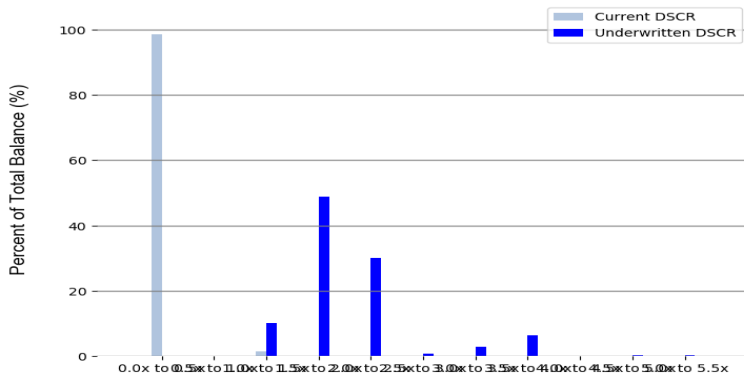

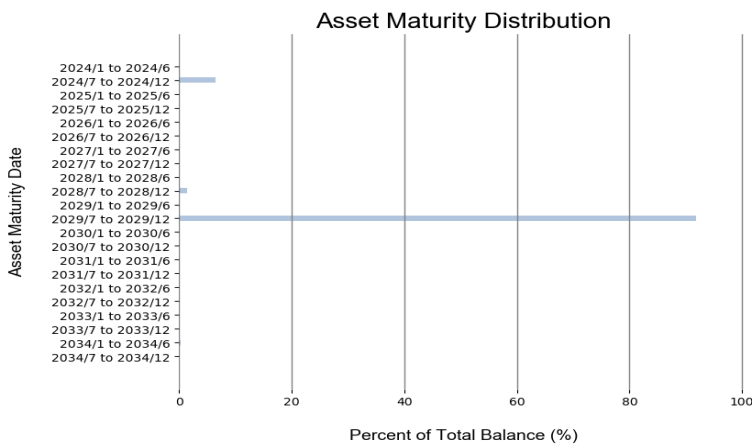

DSCRs ranged from 0.0x to 1.5x. There are 57 assets (98.5% of total balance) with DSCR between 0.0x and 0.5x and 1 assets (1.5% of total balance) with DSCR between 1.0x and 1.5x. The most recent weighted average DSCR is 1.4x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
