Transaction Summary

The transaction closed on Aug 26 2020 and matures in Jan 2035. The pool's current aggregate principal balance is \$559.6 million compared to \$561.0 million at close.

The largest loan of the pool (10.0%) is secured by PGH17 Self Storage Portfolio located in Nassau County-Suffolk County, NY-5.61% metropolitan area. Occupancy at the subject was 85%. The second largest loan of the pool (8.2%) is secured by Phoenix Industrial Portfolio IV located in metropolitan area. Occupancy at the subject was 82%. The major tenants included Cupertino Electric, Inc. (22.74%) and MWD Logistics, Inc. (21.20%). The third largest loan of the pool (6.3%) is secured by Hilton Garden Inn - Goleta located in metropolitan area. Occupancy at the subject was 68%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.05% and 7 months as of 12/15/2020, respectively. There are a total of 40 loans and 71 properties in the portfolio. The appraisal LTV was approximately 65.9% compared to the Original loan to value (LTV), which was approximately 65.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.24x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.

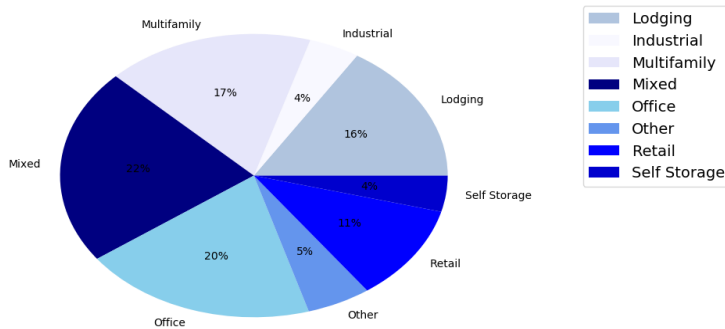

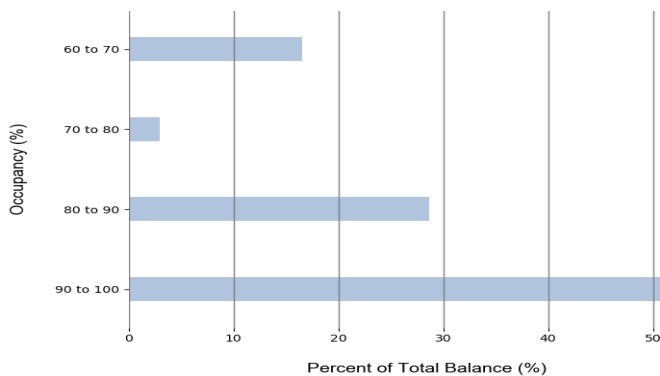

Occupancy Distribution (%)

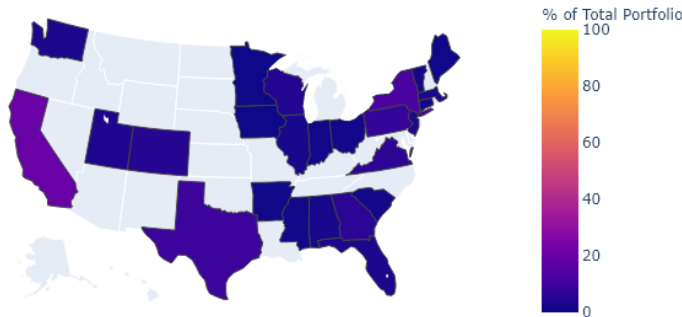

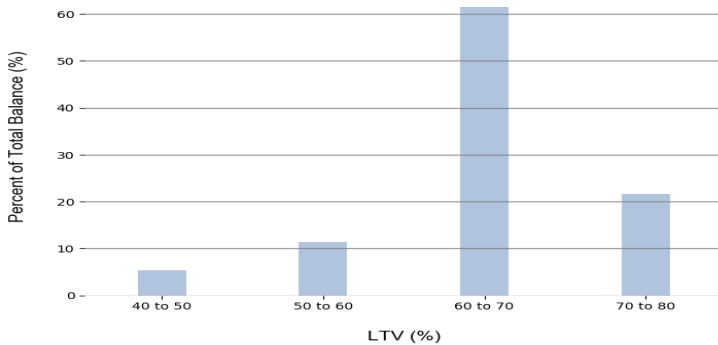
Local Distribution

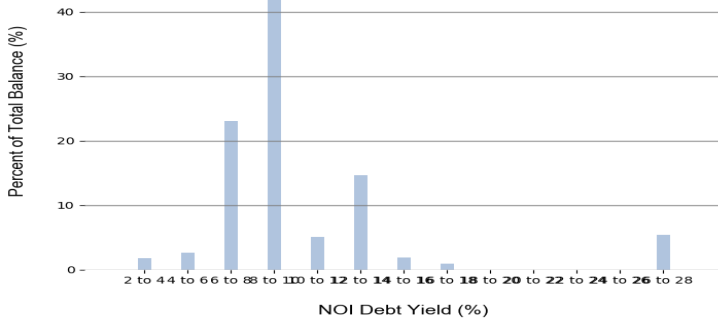

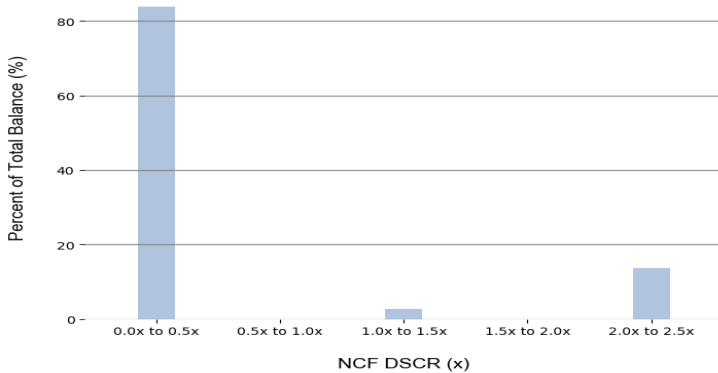
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

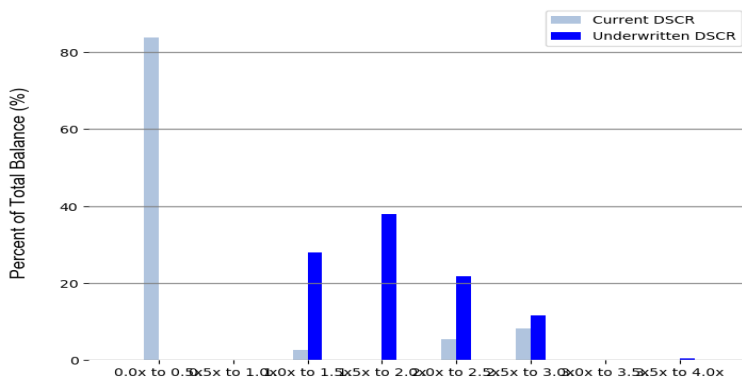

There were 37 assets (83.8% of total balance) with NCF DSCR between 0.0x and 0.5x, 1 assets (2.6% of total balance) with NCF DSCR between 1.0x and 1.5x and 2 assets (13.6% of total balance) with NCF DSCR between 2.0x and 2.5x. The most recent weighted average NCF DSCR was 2.2x.

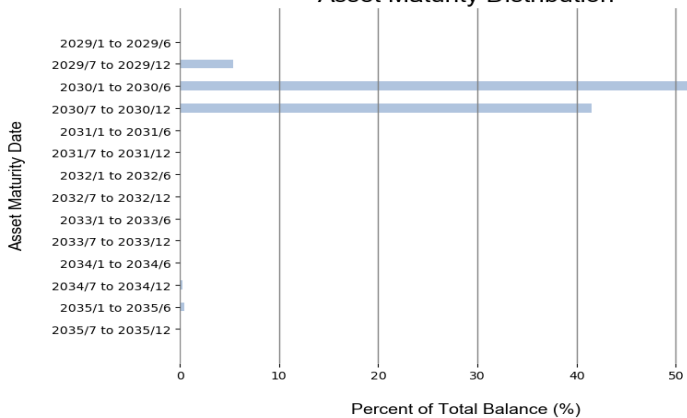
DSCR Distribution (x)

There are 37 assets (83.8% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (2.6% of total balance) with DSCR between 1.0x and 1.5x, 1 assets (5.4% of total balance) with DSCR between 2.0x and 2.5x and 1 assets (8.2% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 2.4x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
