Transaction Summary

The transaction closed on May 13 2014 and matures in Apr 2044. The pool's current aggregate principal balance is \$930.3 million compared to \$1017.2 million at close.

The largest loan of the pool (13.2%) is secured by Woodbridge Center located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 97%. The major tenants included Sears (24.80%) and Boscov's (16.67%). The second largest loan of the pool (6.2%) is secured by Worldgate Centre located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 98%. The major tenants included Worldgate Sport & Health (47.39%) and AMC Cinema (16.67%). The third largest loan of the pool (6.6%) is secured by Sugar Creek I & II located in metropolitan area. Occupancy at the subject was 67%. The major tenants included Noble Drilling Services Inc. (28.27%) and TEAM INC (19.42%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.88% and 80 months as of 12/15/2020, respectively. There are a total of 84 loans and 111 properties in the portfolio. The appraisal LTV was approximately 59.9% compared to the Original loan to value (LTV), which was approximately 63.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.73x. As of 12/15/2020, 4.93% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.

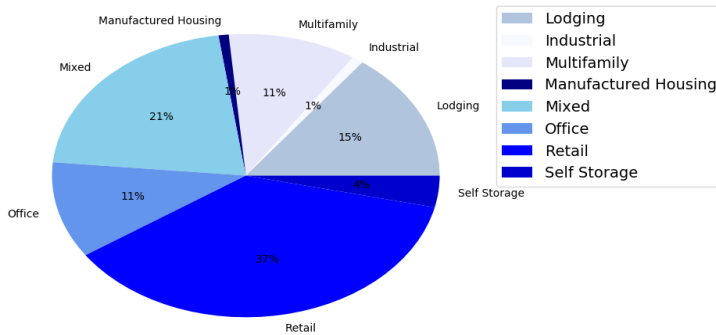

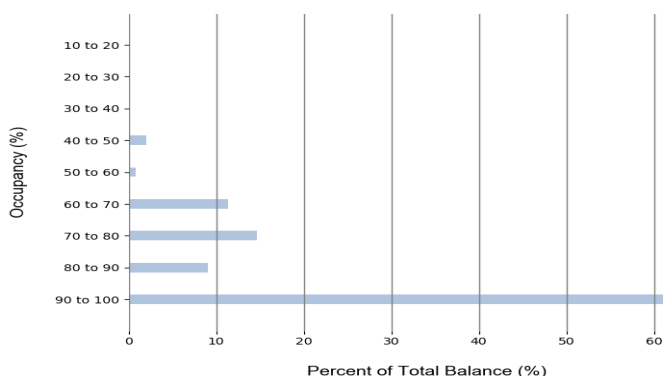

Occupancy Distribution (%)

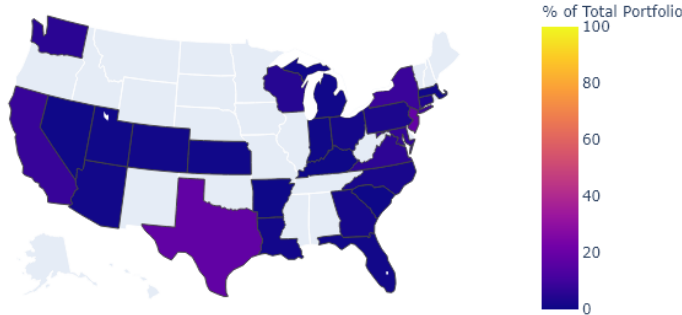

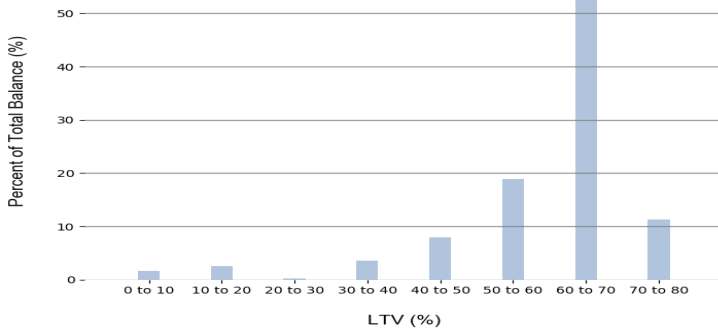
Local Distribution

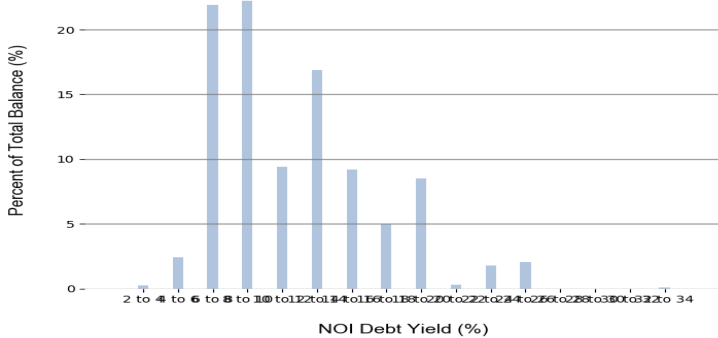

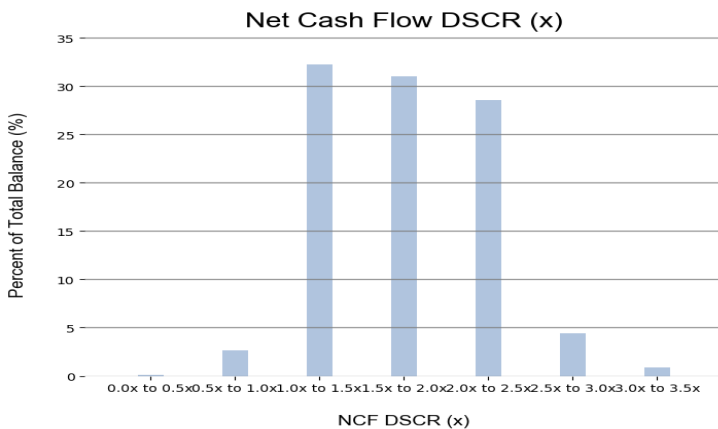

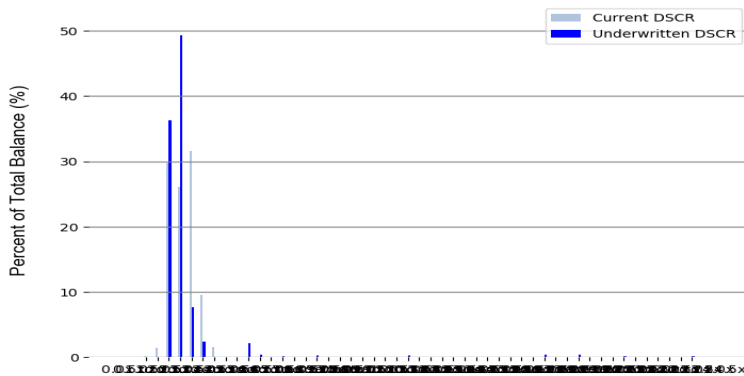
NCF DSCR

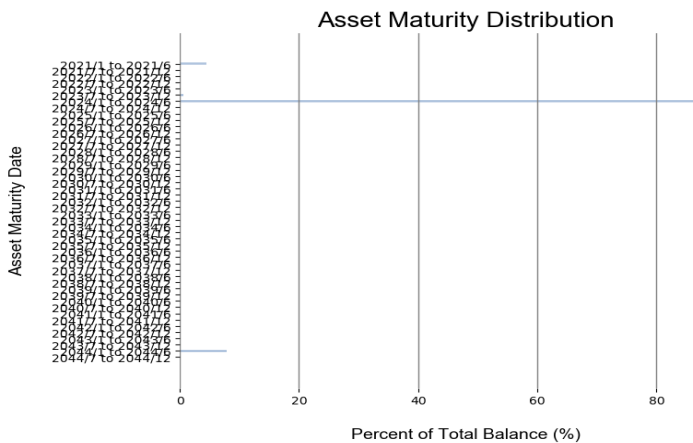

DSCRs ranged from 0.0x to 3.5x. There are 1 assets (0.1% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (1.4% of total balance) with DSCR between 0.5x and 1.0x, 16 assets (29.7% of total balance) with DSCR between 1.0x and 1.5x, 30 assets (26.0% of total balance) with DSCR between 1.5x and 2.0x, 20 assets (31.6% of total balance) with DSCR between 2.0x and 2.5x, 9 assets (9.6% of total balance) with DSCR between 2.5x and 3.0x and 4 assets (1.6% of total balance) with DSCR between 3.0x and 3.5x. The most recent weighted average DSCR is 1.9x.

There are 1 assets (4.4% of total balance) that have maturity dates between 2021/1 and 2021/6, 1 assets (0.6% of total balance) that have maturity dates between 2023/7 and 2023/12, 79 assets (87.2% of total balance) that have maturity dates between 2024/1 and 2024/6 and 3 assets (7.8% of total balance) that have maturity dates between 2044/1 and 2044/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
