Federal Agricultural Mortgage Corporation Class C (AGM) is in the govt support firms sector and its operating income was \$152.1M for the quarter ending June 2023 vs. \$109.7M for the prior year. Net income for the June 2023 quarter was \$47.2M vs. the prior year's \$45.9M income.

Founded in 1987 and headquartered in Washington, DC, Federal Agricultural Mortgage Corporation is a stockholder-owned, federally chartered corporation. It engages in the provision of a secondary market for agricultural real estate and rural housing mortgage loans, rural utility loans, and loans guaranteed by the United States Department of Agriculture. For the FQE Jun'23, net interest income surged 23.0% YoY to \$180.2M partly as a result of higher nominal interest rates. This merely offset the recorded provision for losses of \$1.0M (vs. \$1.4M release), thus, net interest income after provision for losses advanced to \$77.6M (+18.9%). Partially offsetting this were narrowed noninterest income to \$5.9M (-23.5%) due to more than two-fold decline in gains on financial derivatives to \$1.7M, as well as the increases in operating expenses and income tax expense of \$4.1M and \$1.0M, respectively. Hence, YoY net income improved to \$47.2M (vs. \$45.9M). Regarding leverage, total debt rose from \$23.5B to \$24.5B for the FQE Jun'23 while total shareholder's equity rose from \$1.2B to \$1.3B. As a result, leverage (i.e. total debt/capital, including debt) was 94.8%. Net Debt is \$23.64B, while Market Cap is \$1.78B as of 08/31/2023 (a ratio of 13.3:1). Affirming.

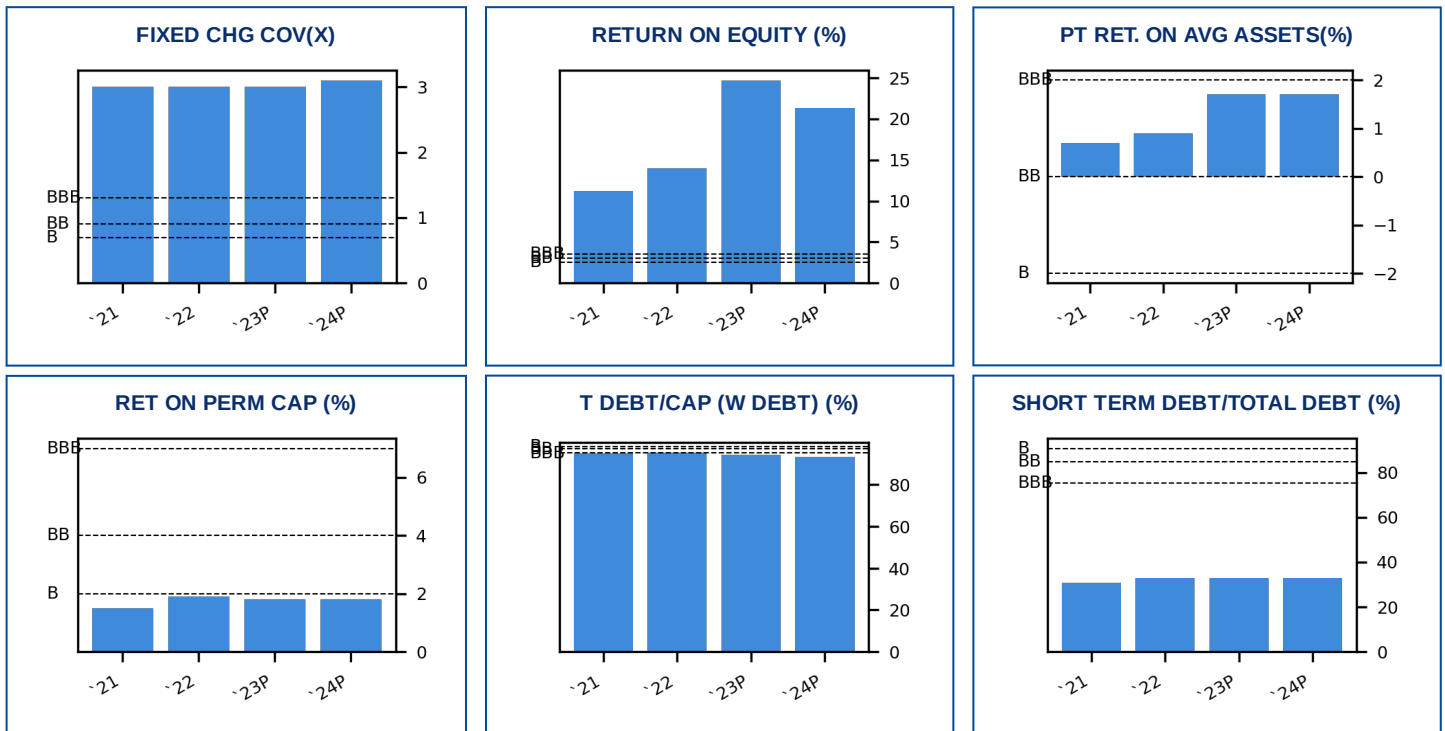

### VALUATION DRIVER: Interest Income Growth

Federal Agricultural Mortgage Corporation Class C (AGM) has grown its interest income at 38.6% per annum in the last fiscal year. We expect the Company's revenues will grow approximately 1.5% per annum over the next couple of years and 1.5% per annum for the next couple of years thereafter.

### VALUATION DRIVER: Net Interest Margin

The Company's net interest margin has been more than its peers and we assumed a 1.8% net interest margin over the next two years.

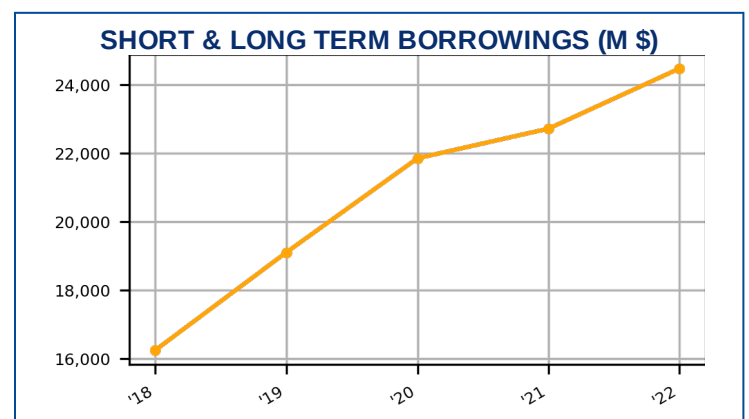
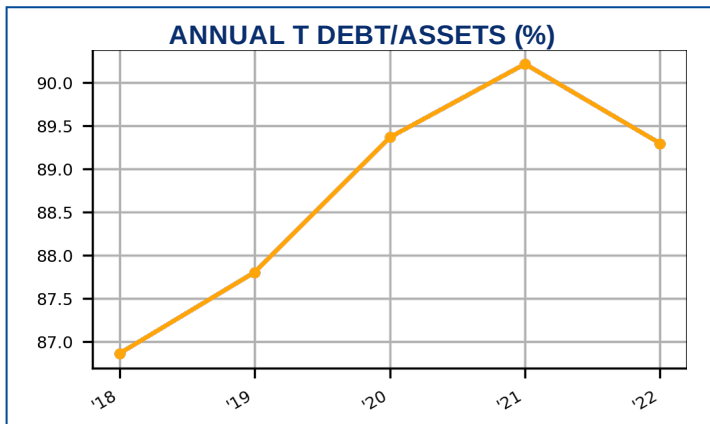

For the issue Federal Agricultural Mortgage Corporation Class C with the ticker of AGM we have assigned the senior unsecured rating of A. There are three notches in our rating categories (e.g., A- A, and A+) except for AAA and those deep into speculative grade, i.e., CC, C, and D do not have notches.

**2. The version of the procedure or methodology used to determine the credit rating as required by Paragraph (a)(1)(ii)(B) of Rule 17g-7:**

The credit rating assigned reflects our judgement regarding the future credit quality of the issuer. Regarding the specific assumptions used, please refer to page 3 of this Rating Analysis Report.

Our rating pertains solely to our view of current and prospective credit quality. Our rating does not address pricing, liquidity, or other risks associated with holding investments in the issuer. EJR ratings

- Do not address investment merit, whether a particular rated security is suitable for a particular investor or suitable for an investor's risk tolerance;

Our rating is dependent on numerous factors including the reliability, accuracy, and quality of the data relied used in determining the credit rating. The data/ information (collectively "Information") is sourced from publicly-available 10Q and 10K statements, quarterly reports, 8K filings, earnings reports, and other similar sources. In some cases, the Information is limited because of issues such as short operating histories, lack of reported data, delay in reporting data, restatements, inaccurate accounting, and other issues. Such shortcomings are not always readily apparent.

**6. Whether and to what extent third-party due diligence services have been used in taking the rating action as required by Paragraph (a)(1)(ii)(F) of Rule 17g-7:**

EJR does not utilize third-party due diligence.

**Non-performing Loans and Credit Losses** - A material increase in non-performing loans and/or credit losses could prompt us to lower or the rating up to several notches.

**Net Interest Margins** - A material decline in the issuer's realized net interest margins could prompt us to reduce our rating up to several notches; the level of the rating cut would depend on the magnitude of the decline and a review of other possibly offsetting factors.

**Regulatory/ Licensing Issues** - A material deterioration in the issuer's regulatory posture is likely to impact credit quality and resulting rating with a decline of up to several notches.


